## SPECIAL ORDER OF FOREST SUPERVISOR UINTA-WASATCH-CACHE NATIONAL FOREST SALT LAKE RANGER DISTRICT

#### TEMPORARY AREA CLOSURE

### **PROHIBITION:**

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System area described in this order. The area affected is located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect beginning April 6, 2022 through December 31, 2025.

1. **Possessing an unleashed dog(s)** on even-numbered days anywhere in Mill Creek Canyon. [36 CFR 261.58(s)]

# **EXEMPTIONS:**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

- 1. Persons with a permit specifically exempting them from the effect of this order.
- 2. Any Federal, state, or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
- 3. Federal or State administrative personnel in performance of an official duty.

### **AREA DESCRIPTION:**

Mill Creek Canyon and adjacent National Forest lands that are located within Mill Creek Canyon located in Township 1 South, Range 2 East, Sections 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, and 36; Township 1 South, Range 3 East, Sections 29, 30, 31, 33, and 34; Township 2 South, Range 2 East, Sections 1, 2, 3, 4 5, 10, and 11; Township 2 South, Range 3 East, Sections 3, 4, 5, 6 and 8 all within the Salt Lake Based Meridian. See attached map.

#### **PURPOSE:**

Purpose of the temporary area closure is to provide for public safety and reduce user conflicts in Mill Creek Canyon and to be in accordance with Salt Lake County leash law ordinance F (<a href="http://saltlakecounty.elaws.us/code/coor\_title8\_ch8.04\_sec8.04.170">http://saltlakecounty.elaws.us/code/coor\_title8\_ch8.04\_sec8.04.170</a>)

### **IMPLEMENTATION:**

- 1. This Order will be in effect April 6, 2022 through December 31, 2025.
- 2. Attached map shows the area affected by this Order.
- 3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
