West Zone Firewood Information Sheet - October 13, 2023

Free Use Firewood Permits on the Mt. Hood National Forest are free of charge for personal use through November 30, 2023.

Please visit us during office hours listed below to obtain your firewood permit in person or send us your completed Personal Use Firewood Permit Application: www.fs.usda.gov/goto/mthood/firewood.

- Mt. Hood National Forest permits harvest of up to six cords per household each year for personal use.
- > Pursuant to 36 CFR 261.6 (F), firewood obtained under this free use authorization may not be sold or exchanged. Please visit our website or call to inquire about the \$10/cord commercial firewood permit.
- ➤ Bring your signed permit, load tags, map, and information sheet with you AT ALL TIMES when gathering firewood; show along with identification if asked by a Law Enforcement Officer.
- **Permits not valid in areas closed to motor vehicles.** Check before selecting your woodcutting area.
- ➤ Pack it in, pack it out! Scatter organic debris from woodcutting, pack out litter, do not cause damage.

Proceed in the burned area with caution

- Memaloose Weigh Station Firewood Deck: Hwy 224, MP 33.5, indicated by green "woodcutting area" signs.
- Blowdown along FR 4640 Tag Creek Rd within 100 ft of road, see West-side Firewood Map for details.
- Hillockburn Rd (NFS 45) is open to FR 4500310 See map.
- FR 4620 wood decked near junction of Hwy 224/Sandstone.
- FR 4610 Firewood Decks: between N. Fork Quarry and Tumala Creek, via Tumala Mt. Rd/FR4614, right on 4613, left on 4610, continue up towards Huxley Lk Trailhead #507.

High Rocks and Timothy Lake Area Roads:

- Access via FSR 42/Skyline Road
- Respect "no trespassing" signs, USFS Permit not valid on tribal lands including Skyline Rd from 4200240 to 4280. See Firewood Maps.
- Watch out for log trucks and traffic!

West Zone (Unit 2) IFPL Level I, "Low" Fire Danger.

Chainsaws must be equipped with .023" or smaller mesh spark arrestor, carry 8" shovel and 8 oz. or larger pressurized fire extinguisher. Remain on site for a one-hour "fire watch" after equipment shutdown to extinguish new starts.
