


Terwilliger Hot Springs Occupancy and

FOREST ORDER OCCUPANCY AND USE

Pursuant to 16 USC 551 and 36 CFR § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited in the areas and on the roads described in this Order. This Order is effective March 15, 2024, through March 15, 2026, or until rescinded.

PROHIBITIONS:

- (1) Parking or leaving a vehicle in violation of posted instructions. 36 CFR 261.58 (g).
- (2) Entering or using the Terwilliger Hot Springs site use area from sundown until sunrise. 36 CFR 261.58 (I)
- (3) Possessing a beverage which is defined as an alcoholic beverage by Oregon State law. 36 CFR 261.58 (bb). Possession also includes the consumption of the beverage.
- (4) Being publicly nude visible from Forest Road 19. 36 CFR 261.58 (j).

CLOSURE AREA DESCRIPTION:

The area as described on the attached Map (Exhibit A):

Prohibitions 1-4 apply within the Terwilliger Hot Springs Site Use Area on the McKenzie River Ranger District starting at milepost 51 on FS Road 19, traveling east to the water's edge, then south along the water edge of Cougar Reservoir approximately 1 mile to section line 20, then west along the section line 20 which crosses FS Road 19, and continuing west to the section line dividing sections 19 and 20. From this point, traveling north along the section line to where sections 17, 18, 19, and 20 meet. From this point traveling east on the ridge and along the section line to the beginning point.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- (2) Any Federal, State, or Local Officer or member of an organized rescue or fire-fighting force in the performance of an official duty.

These restrictions are implemented for the safety of the public.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subparts A.

Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC§ 551; 18 USC§§ 3551, 3559, 3571 and 3581).
