Subject: Administrative Change to 2018 Flathead National Forest Land Management Plan

This letter documents the following administrative changes made to the Flathead National Forest Land Management Plan (2018 Forest Plan) to correct inaccuracies and incorporate improved geospatial accuracy:

- To incorporate greater accuracy in geospatial data for the Jewel Basin, Limestone-Dean Ridge, and Tuchuck-Whale Recommended Wilderness Areas (RWAs), Table 24 (*Total approximate acres of areas recommended for inclusion in the National Wilderness Preservation System*) is being updated to reflect minor acreage changes due to the corrections.
- Four administrative areas were erroneously labeled as fire lookouts rather than airstrips in Table 27 (*Administrative sites*). The table is being updated to incorporate the correct labels.

# **Administrative Changes**

Corrections to Recommended Wilderness Area Boundaries and Table 24 The Jewel Basin, Limestone-Dean Ridge, and Tuchuck-Whale RWA boundaries were intended to fully exclude several National Forest System trails from the RWAs to allow mechanized, non-motorized use. Minor inaccuracies, however, were recently discovered.

RWA boundaries were drawn using the best information available during plan revision. Data with improved geospatial accuracy relating to geological features and existing infrastructure is now available, and indicates that small portions of five trails that should have been wholly outside the RWAs were actually within RWA boundaries in certain locations.

As summarized below in Table 1, the Jewel Basin, Limestone-Dean Ridge, and Tuchuck-Whale boundaries will be corrected to exclude these trails and incorporate current geospatial data to align with management area intent.

The analysis in the Forest Plan final environmental impact statement remains unchanged and accurately describes resource conditions and management activities. Actual trail locations will remain unchanged, and eligibility for inclusion in the National Wilderness Preservation System is not affected.

Due to these corrections, the following corrections are being made to Table 24 on page 89 of the 2018 Forest Plan. Corrections are in bolded text.

### Corrections to Administrative Site Types in Table 27

Four administrative areas were erroneously labeled as fire lookouts rather than airstrips. As a result, the following corrections are being made to Table 27 (*Administrative sites on the Forest*) on page 96 of the 2018 Forest Plan. Corrections are in bolded text. Only the four rows below are being corrected. The remainder of the table remains unchanged.

These changes to the 2018 Forest Plan are being made in accordance with the administrative change process of 36 C.F.R. § 219.13(c)(2). The administrative change process is appropriate to use because:

- It allows for the correction of clerical errors. 36 C.F.R. § 219.13(c).
- Clerical errors include "an error of the presentation of material in the plan such as phrasing, grammar, typographic errors, or minor errors in data or mapping that were appropriately evaluated in the development of the plan, plan revision, or plan amendment." 77 Fed. Reg. 21161 at 21239.
- The changes documented in this letter are limited to the correction of minor errors in data or mapping (RWA boundaries) and typographical errors (administrative site types).
