Temporary Second Dam Day Use Area Closure

PROHIBITIONS

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50 (a)(b), **the following acts are prohibited** on the National Forest System Second Dam Day Use Area in the Logan Ranger District, Uinta-Wasatch-Cache National Forests. Described below and shown on the attached map incorporated into this Order as Exhibit A. This Order will be in effect November 27, 2023, and shall remain in effect until April 30, 2024, unless rescinded.

1. **Going into or be upon the Second Dam Day Use Area including all parking areas and the entire pond** this includes all pedestrian, equestrian, bicycle, and any type of motorized vehicle, as described below and as shown on attached map. [36 CFR 261.53(e)]

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
2. Any federal, state, or local officer, or member of an organized rescue or firefighting resource in the performance of an official duty.
3. Federal or state administrative personnel in performance of an official duty.

DESCRIBED

The Second Dam Day Use Area is closed including all parking areas and the entire pond located in Township 12 North, Range 2 East, Section 29 and 32, all within the Salt Lake Base Meridian, as shown on the attached map. The River Trail (Forest Service Trail #7603) will remain open for use.

PURPOSE

Purpose of the Closure is to provide for public health and safety while Logan City is dredging sediment from the Second Dam Area.

IMPLEMENTATION

1. This Order will be in effect when signed November 27, 2023, and shall remain in effect until April 30, 2024, unless rescinded.
2. A map identifying the area is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to [Uinta-Wasatch-Cache National Forest - Alerts & Notices \(usda.gov\)](https://www.usda.gov/alerts-notice).
3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

6. This Order supersedes any previous Orders prohibiting the same or similar acts in/on the Second Dam Day Use Area including all parking areas and the entire pond.
