Road Restriction Order: Spring Road Closures

PROHIBITIONS

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), the following are prohibited on the National Forest System (NFS) roads on the Libby and Rexford/Kasanka Ranger Districts, Kootenai National Forest, described below in Exhibit A and shown on the attached maps incorporated into this Order as Exhibit B (the "Described Roads):

 All motorized vehicles over 10,000 lbs. GVW (gross vehicle weight) are prohibited from using or being operated on the designated roads described further in Exhibit A and shown on the attached maps incorporated into this Order as Exhibit B. 36 C.F.R. § 261.54(a) and 261.54(d)

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
- 2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

DESCRIBED ROADS

Roads described on the attached Exhibit A and as depicted on the maps attached as Exhibit B and herby incorporated into this Orders.

PURPOSE

This restriction is to prevent damage to road surface and base due to thawing action or excess moisture.

IMPLEMENTATION

- 1. This Order shall be in effect from February 20th, 2024 through June 30th, 2024, unless rescinded.
- 2. A map identifying the Described Roads is attached and made part of this Order as Exhibit B. For a digital version of this Order and Exhibit A, go to https://www.fs.usda.gov/alerts/kootenai/alerts-notices
- 3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
- 4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

- 6. This Order supersedes any previous Orders prohibiting the same or similar acts in/on the same Described Area/Road/Trail.






ROAD RESTRICTION - FORTINE CREEK/WOLF CREEK - #36




ROAD RESTRICTION - SEVENTEEN MILE CREEK - #471




ROAD RESTRICTION - DUNN CREEK/WOLF CREEK - #525




ROAD RESTRICTION - MCKILLOP MCGINNIS - #535




ROAD RESTRICTION - MCKILLOP APPROACH ROAD - #5802




ROAD RESTRICTION - KOOCANUSA WEST SIDE - #228




ROAD RESTRICTION - CRIPPLE HORSE WEIGLE - #835




ROAD RESTRICTION - QUARTZ CREEK- #600




ROAD RESTRICTION - CRIPPLE HORSE FISHER RIVER - #334




ROAD RESTRICTION - BOUNDARY MOUNTAIN - #4904




ROAD RESTRICTION - CANYON CREEK/WEST DRY FORK - #4912
