SPECIAL ORDER OF FOREST SUPERVISOR UINTA-WASATCH-CACHE NATIONAL FORESTS HEBER-KAMAS RANGER DISTRICT

TEMPORARY ROAD CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) and (b), the following acts are prohibited on the National Forest System road described in this Order. The road affected is located on the Heber-Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting July 1, 2022 and shall remain in effect until October 31, 2026.

1. **Being in or upon the** Forest Service road #055, as described below and shown on the attached map. This includes all motorized vehicles, pedestrian, equestrian, and bicycle use. [36 CFR 261.53 (e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

- 1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Forest Service road #055 is closed at the junction with Forest Service road #96 located in Township 4 South, Range 7 West, Sections 29, and 30, all within the Salt Lake Based Meridian as shown on attached map.

PURPOSE:

Purpose of the closure is to provide for public health and safety while timber crews are cutting and removing timber as part of the salvage timber sale.

IMPLEMENTATION:

- 1. This Order will be in effect when signed July 1, 2022 and shall remain in effect until October 31, 2026
- 2. Attached map shows the area affected by this Order.
- 3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
