ORDER # 06-18-00-21-25

FOREST ORDER

Pursuant to 16 USC § 551 and 36 CFR 261.50(a) and (b), and to provide for public safety, the following acts are prohibited in the areas, roads, and trails described in this order on National Forest System lands within the administrative boundaries of the Willamette National Forest. This Order is effective on November 8th, 2021 and shall be in effect through October 31, 2022, unless rescinded sooner. This order supersedes and rescinds order 06-18-00-21-31, which was signed August 31st, 2021 by Forest Supervisor David Warnack.

PROHIBITIONS:

1. Being on a road. **36 CFR § 261.54(e)**
2. Being on a trail. **36 CFR § 261.55(a)**
3. Entering or using a developed recreation site or portion thereof. **36 CFR § 261.58(b)**
4. Entering into or being upon National Forest System Lands closed for the protection of public health or safety. **36 CFR § 261.53(e)**

CLOSURE DESCRIPTION:

All closures are contained within the State of Oregon, within Marion and Linn Counties, and within the Administrative Boundaries of the Willamette National Forest. The closed portions are all US Forest Service general forest areas, developed recreation sites, National Forest System roads, and National Forest System trails as described below and as depicted on the attached map and incorporated into this order as "Attachment A".

The Beachie Creek and Lionshead Closure Area boundary begins at the intersection of State Highway 22 and the burned area boundary halfway between MP 62 and 63 in Section 28, T 10S, R 7E. It proceeds west, following the burned area boundary, until it reaches Section 5, T 11S, R 6E. The closure includes the portion of Forest Road 1011 that overlaps with the closure boundary. The closure area boundary continues north along the burned area boundary until it reaches Section 20, T 10S, R 6E before going east along the burned area boundary until reaching Section 26, T 10S, R 6E. It then proceeds north and west along the burned area boundary until it reaches the eastern-most edge of the City of Detroit in Section 7, T 10S, R 6E before following the Willamette National Forest administrative boundary to the eastern bank of the Upper Arm of Detroit Lake in Section 1, T 10S, R 5E. The closure boundary then turns south and west along the northern edge of Detroit Lake until it reaches Section 17, T 10S, R 5E before turning north and west on the edge of the lake until Detroit Dam Road in Section 7, T 10S, R 5E before turning south along the western edge of Detroit Lake until the intersection of Detroit Lake

with the Willamette National Forest administrative boundary at Section 19, T 10S, R 5E. Then it proceeds north along the Willamette National Forest administrative boundary to the south edge of the Opal Creek Scenic Recreation Area at Section 12, T 9S, R 4E. From there it proceeds west and north along the Opal Creek Scenic Area boundary and then east along the Opal Creek Wilderness boundary until it meets the Bull of the Woods Wilderness boundary in Section 21, T 8S, R 5E. The closure boundary then follows the Willamette National Forest administrative boundary south and east to the boundary with the Warm Springs Indian Reservation and follows the Willamette National Forest administrative boundary south to its intersection with burn area boundary in Section 23, T 10S, R 8E. Then it follows the burn area boundary west until it reaches State Highway 22.

National Forest System lands on Piety Island located within Sections 10 and 11, T 10S, R 5E and Stahlman Point Trailhead located within Section 14, T 10S, R 5E are also included in the closure.

EXEMPTIONS:


Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically exempting them from this Order;
- (2) Any Federal, State, or Local Officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of these prohibitions are punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for a corporation or imprisonment for not more than six months or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3551, 3559, 3571, and 3581.
