

### FOREST ORDER

## OCCUPANCY AND USE - ROAD AND AREA CLOSURE

Pursuant to 16 USC 551 and 36 CFR § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited in the areas and on the roads and trails described in this order within the administrative boundaries of the Willamette National Forest. This Order supersedes Order # 06-18-01-23-02. This Order is effective on January 1, 2024, through December 31, 2024, or until rescinded whichever comes first.

## **PROHIBITIONS**:

- 1. Being on a road. 36 CFR § 261.54(e)
- 2. Being on a trail. 36 CFR § 261.55(a)
- 3. Entering or using a developed recreation site or portion thereof. **36 CFR § 261.58(b)**
- 4. Entering in to or being upon National Forest System Lands closed for the protection of public health or safety. **36 CFR § 261.53(e)**

### **CLOSURE DESCRIPTION:**

The closure areas, described below and shown on Exhibit A, include all US Forest Service developed recreation sites, roads, and trails.

To protect the health and safety of the public: due to danger trees from the Holiday Farm Fire, the following roads, trails and areas are closed to all traffic (including vehicle, bike, and pedestrian):

- Approximately 2.4 miles of Forest Road 2820 between the gates in sections 1 and 32.
- Forest Roads 1900-400, 1900-415 and 1900-416
- the area bounded by the mainstream McKenzie River and South Fork McKenzie River from their confluence, east to road 1900 as depicted on Exhibit A. This area includes the former Delta Campground and former Delta Old Growth trail.

## **EXEMPTIONS**:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order;
- (2) Any Federal, State, or Local Officer or member in the performance of an official duty.

These restrictions are implemented for the safety of the public.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subparts A.

Violations of this prohibition are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC §§ 3551, 3559, 3571 and 3581).
