# U.S. Department of Agriculture, U.S. Forest Service Salmon-Challis National Forest North Fork Ranger District

## Occupancy and Use

#### **PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50 (b), the following acts are prohibited on the National Forest System (NFS) Road in the North Fork Ranger District of the Salmon-Challis National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Road"):

- 1. Camping or possessing camping equipment on the roadway, except in a turnout that does not impede travel on NFSR #30. 36 CFR 261.58(e).
- 2. Building, maintain, attending, or using a fire on the roadway. 36 CFR 261.52(a).
- 3. Parking or leaving a vehicle in violation of posted instructions. 36 CFR 261.58(g)

#### **EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
- 2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

## **DESCRIBED ROAD**

This Order applies to NFS Road #030, Salmon River Road, beginning at the Junction with Highway 93 and ending at its terminus, Corn Creek Boat Launch, North Fork Ranger District, Salmon-Challis National Forest.

#### **PURPOSE**

The purpose of this Order is to provide for public health and safety and maintain access for emergency vehicles.

## **IMPLEMENTATION**

- 1. This Order shall be in effect from March 30, 2023 at 1200 through March 30, 2028 at 1200, unless rescinded.
- 2. A map identifying the Described Road is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to https://www.fs.usda.gov/main/r4/alert-notices.
- 3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
- 4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

- 6. This Order supersedes any previous Orders prohibiting the same or similar acts in/on the same Described Road.
