# How to Comment and Timeframe

We anticipate that the Environmental Protection Agency will publish the Notice of Availability (NOA) for the DEIS in the Federal Register on Friday, March 29, 2013. Written, facsimile, handdelivered, oral, and electronic comments concerning this action will be accepted for 60 days following that date. The publication date of the NOA in the Federal Register is the exclusive means for calculating the 60-day comment period for a proposed action documented in a DEIS. Those wishing to comment should not rely upon dates or timeframe information provided by any other source. Those who provide comments during this comment period are eligible to participate in administrative review. Interest expressed or comments provided on this project prior to or after the close of this comment period will not constitute standing for participating in administrative review. Comments must meet the requirements of 36 CFR 215.6. In the event this proposal becomes subject to a predecisional objection process rather than appeal, all interested and affected parties who participated during scoping or this comment opportunity will be notified of the change. Names and addresses of commentors will become part of the public record.
