Draft Environmental Impact Statement for the Four-Forest Restoration Initiative,

Coconino and Kaibab National Forests Reader's Guide (updated 4/15/2013)

Thank you for your interest in this four-forest restoration analysis (4FRI) for the Coconino and Kaibab National Forests. The draft environmental impact statement (DEIS) was developed in collaboration with many individuals, groups, and agencies. This guide is intended to provide an overview of the analysis and provide you one-stop shopping information for reviewing and commenting on the DEIS. This guide was revised on March 22, 2013 to correct a website address and to add addresses for the public meetings/open houses. On March 23, 2013 the guide was updated to incorporate new office hours (8 a.m. to 4 p.m.) for the Coconino NF that begin in early April, 2013. On March 29, 2013 this guide was updated to incorporate the Notice of Availability (NOA) which was published on that day. On April 15, 2013, this guide was updated to reflect the change in planning regulations from 36 CFR 215 administrative appeals to 36 CFR 218 predecisional objection process.

- Chapter 1. Purpose and Need for Action. The purpose and need describes why the project is needed by describing the existing and desired conditions as they relate to having a resilient and sustainable forest (see page 8 to page 29). This chapter describes public involvement for the project (see page 34 to page 36), issues that were identified from scoping and collaboration (see page 36 to page 39), and the final proposed action (see page 40 to page 45).
- Chapter 2. Alternatives, Including the Proposed Action. This chapter provides details on alternatives that were considered but eliminated from detailed study (see page 48 to page 61) as well as those alternatives that were analyzed in detail (see page 62 to page 103).
- Chapter 3. Affected Environment and Environmental Consequences. This chapter describes the direct, indirect, and cumulative environmental consequences associated with each alternative (see page 105 to page 332).

- Chapter 4. Consultation and Coordination. This section lists all individuals, organizations, local, state and federal government who are involved, or want to be kept informed (see page 333 to page 339).
- **Glossary**. This section provides definitions for commonly-used terms (see page 341 to page 355).
- **References.** This section provides a list of scientific literature used to inform the analysis. For easier reading, it is organized by resource, DEIS chapter or DEIS Appendix as applicable (see page 357 to page 435).
- Appendix A (Map Packet). - Appendix B (Forest Plan Amendments). Several forest plan amendments were needed in order to move towards restoration desired conditions. The amendments are a bridge between the dated, current forest plans (in place since 1987 and 1988) to the forest plan revision process that is currently underway on both forests. Each action alternative includes up to 6 non-significant forest plan amendments. Table 91 (page 439) provides a summary of the proposed plan amendments.
- Appendix C (Design Features, BMPs, and Mitigation). Appendix C includes design features that would be required to implement alternatives B-D. Some features are required in order to be in compliance with law, regulation, policy, and/or the forest plans. Some features were developed by resource specialists to further reduce impacts to their resource. The design features are carried forward into the implementation monitoring section of the monitoring and adaptive management plan (appendix E, page 659) to gauge whether the features were effective. The design features are also carried forward into the implementation plan (appendix D, page 601) to ensure that the project is implemented as designed.
- **Appendix D** (**Implementation Plan**). The implementation plan (see page 601 to page 657) is designed to ensure compliance with the analysis and decision. It includes checklists and guidance designed to track accomplishments, provide guidance to the implementation team, and utilize adaptive management.

Should a treatment need adapting or modifying to best meet the conditions on the ground, the implementation plan provides the mechanism to evaluate and then document whether the analysis conducted was sufficient or whether new analysis is needed. The implementation plan includes the following:

o **Annual Implementation Checklist.** A checklist (table 112) was developed to track compliance with the NEPA decision and ensure activities are consistent and compliant with the analysis and decision (correct location, appropriate number of acres by treatment type). The checklist is designed to be used by the implementation team leader.

- o **Planned Acres by Treatment Type and Restoration Unit (RU).** A checklist (table 113) was developed to facilitate accomplishment reporting. The checklist is designed to be used (at a minimum) by the implementation team leader and forest program managers.
- NEPA, NFMA, ESA, CFLR Act Compliance Evaluation. The checklist (table 114) is designed to ensure resource surveys are completed as required by the forest plan, policy, U.S. Fish and Wildlife Service (FWS) biological opinion, Comprehensive Forest Landscape Restoration Act (CFLR), or other requirements. The checklist also ensures that the site-specific treatments are compliant with the NEPA analysis and decision. The checklist is designed to be used by the resource specialists that are part of the implementation team and by the Agency's (delegated) approving official.
- O **Supporting Documentation.** This checklist (table 115) is designed to ensure required plans and surveys are tracked annually and are readily accessible to the implementation team and approving official. It will be used in combination with appendix E, the adaptive management strategy.
- Sections A-E: This portion of the Implementation Plan provides guidance specific to the vegetation treatments. It is designed to ensure that tree groups, interspaces, and regeneration openings are designed as planned. It incorporates guidance designed to conserve pre-settlement trees and provides guidance (desired conditions) for retaining large, young trees (alternative C only). Guidance on old and large trees was derived from stakeholder products.
- Appendix E (Monitoring and Adaptive Management Plan). The monitoring and adaptive management plan (see page 675 to page 697) is a collaborative product designed to meet the Collaborative Forest Landscape Restoration Program (CFLRP) requirements for multiparty monitoring. It provides guidance for measuring physical and biophysical, social, and economic results of restoration activities across the 4FRI analysis area. It provides a feedback mechanism that supports adaptive management. The plan is a work in progress and will likely be refined before the project's decision is issued.
- **Appendix F** (**Cumulative Effects**). The cumulative effects appendix (see page 675 to page 697) includes the past, present, and reasonably foreseeable information that was gathered to evaluate cumulative effects. As needed, each specialist modified this list to make it site-specific to their resource. Cumulative effects maps are available for viewing on the 4FRI website or in hard copy form.
- Appendix G (Bridge Habitat). The bridge habitat evaluation (see page 699 to page 713) was developed in response to public concerns that wildlife species (including the northern goshawk, the Mexican spotted owl, Abert's squirrel, turkey, mule deer, black bear, and some songbird species) would not have sufficient post-treatment closed canopy habitat. The evaluation clarifies how post-treatment conditions within the 4FRI project area would provide habitat for canopy-dependent wildlife in the short term. We are referring to those areas as "bridge habitat," suggesting that these more densely forested areas would be available to wildlife to bridge the time between treatment and the attainment of desired conditions across the broader landscape.
- **Index**. The index provides a way to search the DEIS for key words or areas of interest by page number (see page 715 to page 716).

Preferred Alternative – Alternative C

- This alternative would mechanically treat 434,001 acres of vegetation and utilize prescribed fire on 593,211 acres.
- It responds to Issue 2 (conservation of large trees) and Issue 4 (increased restoration and research).
- It adds acres of grassland treatments on the Kaibab NF, incorporates wildlife and watershed research on both forests, and mechanically treats and uses prescribed fire within the proposed Garland Prairie Research Natural Area on the Kaibab NF.
- It proposes mechanically treating up to 18-inch d.b.h. in 18 MSO PACs and includes low severity prescribed fire within 72 MSO PACs, including 56 core areas.
- Key components of the stakeholder created Large Tree Retention Strategy are incorporated into the alternative's implementation plan.
- Three nonsignificant forest plan amendments on the Coconino NF and three nonsignificant amendments on the Kaibab NF would be required to be in compliance with the plans.

Decision to be Made

The Coconino and Kaibab NF Supervisors are the Forest Service officials responsible for making the final decision. Earl Stewart is the Coconino NF Forest Supervisor and Mike Williams is the Kaibab NF Forest Supervisor. For more information on the decision to be made, see page 29 of the DEIS.

How to Comment and Timeframe

In response to public input, the Forest Supervisors decided to offer a 60-day formal comment period. The Environmental Protection Agency published the Notice of Availability (NOA) for the DEIS in the Federal Register on Friday, March 29, 2013. The 60-day comment period ends on May 29, 2013. The publication date of the NOA in the Federal Register is the exclusive means for calculating the 60-day comment period for a proposed action documented in a DEIS.

Written, facsimile, hand-delivered, and electronic comments concerning this action will be accepted for 60 days following that date. Those who provide comments during this comment period are eligible to participate in the predecisional objection process. Interest expressed or comments provided on this project prior to or after the close of this comment period will not constitute standing for participating in the predecisional objection process. Comments must meet the requirements of 36 CFR 218.22. Names and addresses of commentors will become part of the public record.
