SPECIAL ORDER
Seeley Fire

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50 (a) and (b) the following act is prohibited in the area, road, or trail as described in this order, all within the Ferron/Price Ranger District, Manti-La Sal National Forest until further notice.

1. Being on the National Forest System Road described below with motorized vehicles. [36 CFR 261.54(e)]
2. Being on the National Forest System Trail described below. [36 CFR 261.55(a)]
3. Camping is prohibited at Forks of Huntington Campground, Bridges Group Site A and sites 1-4, and South Hughes Group Site as depicted on the enclosed map; for the protection of public safety and health. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

National Forest System Road included:

Nuck Woodward Road (FS Road 0110) from the Nuck Woodward Trailhead in Township 15 South, Range 7 East, Section 9 to the head of the canyon in Township 14 South, Range 7 East, Section 15.

National Forest System Trail included:

Pole Canyon (FS Trail 073)

PURPOSE:

This Order will remain in effect until rescinded. This Order is in place to facilitate the completion of hazard mitigation and to protect the public from falling trees and post-fire debris flows within and downstream of the Seeley Fire burned area.

IMPLEMENTATION:

1. This order will be in effect when signed and shall remain in effect until further notice.
2. A list of areas identifying the closed areas is attached and made part of this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571 (b) (6), Title 18 USC 3581 (b) (7)]
4. Further information regarding this Order may be obtained at the Ferron/Price District Office, (801) 384-2372, and the Manti-La Sal National Forest Supervisor's Office, (435) 637-2817.
5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order on the roads covered by this Order.
