This is our final response to your Freedom of Information Act (FOIA) request #2018-FS-R8-03900-F of May 1, 2018, which was received in this office on May 3, 2018. You requested the following information:

 "Any documents prepared by Galileo Project, LLC, bearing the title(s) "Mountain Valley Pipeline" and/or "Internal FS Law Enforcement (LE) Call" created between the dates of March 1, 2017 and May 3, 2018."

A reasonable search was conducted by this office and all responsive records were referred to the Office of the General Counsel, U.S. Department of Agriculture for mandatory review on May 16, 2018. Upon review of these records (8 pages) it has been determined that (4) pages have been partially redacted in accordance with 5 U.S.C. § 552(b)(7)(A) and 5 U.S.C. § 552(b)(7)(E). The remaining (4) pages are being released in full.

### Exemptions

FOIA Exemption 7 protects from disclosure "records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of a confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of a record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or (F) could reasonably be expected to endanger the life or physical safety of any individual."

We have determined that certain information that is the subject of your request must be withheld pursuant to Exemption 7 of the FOIA, 5 U.S.C. § 552(b)(7)(A)(E).

### **Fees**

Pursuant to 7 C.F.R. Subtitle A, Part 1, Subpart A, Appendix A, there is no charge for the records enclosed. At our discretion, we have chosen not to charge fees in this case because we believe the release of the records at issue to be in the public interest.





This discretionary waiver of fees applies to this particular FOIA request and does not guarantee a waiver of fees when similar records are requested in the future; nor does it guarantee a waiver of fees to you when making future requests or appeals.

## **Appeal Rights**

### **ACTION ITEMS**

- **Jennifer** sends comments on the Plan of Development (POD) appendices from Katie JoBeth to MVP.
- JoBeth and Katie coordinate emergency notification
- MVP asks ATC who to call in case of an event affecting the ANST.
- FS has conversations internally and lets MVP know who and when to call people.
- Megan gets into contact with Mary Krueger and Andrew (ATC) for their LE response preferences.
- MVP coordinates communication protocols for areas in the proposed Right of Way (ROW) with no cellular service.
- Duane follows up with Law Enforcement to discuss specific security duties as it gets closer to construction, if the project is approved.
- Katie contacts Duane with special agent Willet's information as well.
- MVP develops a compliance and safety training and forwards on to FS and BLM for review.
- Grace forwards project milestones schedule to agency participants on the call.
- FS discusses which law/safety stipulations FS needs in BLM's ROW grant, if approved.
- Alex and Jennifer coordinate delivery of FS operating plan requirements to MVP.

### **DISCUSSION/DECISIONS**

- Katie said it is not feasible to process road closures for construction at this point in time, but
  that the district ranger has the authority to issue temporary closures as needed for specific
  areas during construction. FS does not issue closure orders post-construction, but rather
  uses regulations already in place to work with any potential issues or illegal activities in the
  proposed ROW.
- MVP confirmed they do not plan to use Brush Mountain Road for construction and operation of the proposed pipeline, if approved.
- Katie clarified MVP is responsible for the safety of their own personnel and equipment, in conjunction with state personal for issues of a certain legality. Any issues with FS personnel, lands, and equipment are the jurisdiction of FS law enforcement.



## (b) (7)(A), (b) (7)(E)

- All parties agreed additional coordination with BLM, FS, the Appalachian Trail Conservancy, and the National Park Service is warranted to identify points of contact and communication expectations.
- Katie stated she is available 24/7 as a point of contact for issues on the Jefferson National
  Forest or with FS Personnel. FS would like immediate notifications for any trespass issues,
  protests, fatalities, medical emergencies, fires, explosions, damage, etc. on FS lands. Kelly
  said she plans to notify FS of minor incidents, protest planning activity, etc.
- (b) (7)(A), (b) (7)(E)
- Jennifer stated details of communication protocols need to be included in MVP's POD.
- James suggested MVP start thinking how to enforce protections and safety on the ROW for post-construction maintenance and operation phases.
- Jennifer recounted the current project milestones to include a potential certificate from the Federal Energy Regulatory Commission (FERC) by September 23, 2017, and a Biological Opinion from the US Fish and Wildlife Service by November 22, 2017. Jennifer warned that FERC will likely not notify MVP or cooperating agencies before they release their certificate.

# Objective: Develop a coordinated approach to dealing with questions from folks who are near the right of way.

Forest Service (FS) staff has guidance on phone calls, but not in the field. Recently, there was a couple who approached staff and separated the FS folks from the Enterprise folks. There have also been some letters and phone calls.

FS wants staff to be able to provide service-oriented response. FS wants to make sure there is some response to casual users who encounter workers, so Jessica Rubado, the FS Communication Lead, has distributed a handout, as well as her business cards for people who have more questions, for staff on the ROW to hand out. Staff is directed to send folks to Jessica for more information. Jessica expressed interest in having MVP review the document.

Action: Jessica sends the talking points to Natalie Cox for review.

Action: James will take the lead on discussing FS messaging with FS management.

MVP asks contractors to have anyone who approaches them to send an email, contact the hotline, or call Natalie Cox. MVP wants to limit the number of persons who are actually providing information. There is concern about getting recorded and having recordings edited.

The group agreed that there should be communication between the MVP and Agency communication staff. This will help in developing coordinated and consistent response.

Examples of when staff should contact each other right away include:

- Contact with media and local officials.
- Contact with major stakeholders or groups,
- Protests or demonstrations, and
- Any hostile or unusual encounters.
- Best judgment should be used on more casual encounters.

- Troy contacts Ginny Williams (FS) to clarify concerns on Right of Way (ROW) undulations.

#### **DECISIONS/DISCUSSION POINTS**

 Captain Ballew (FS) met with Virginia law enforcement to provide an overview of the MVP project. FS anticipates needing assistance from local law enforcement as the implementation phase of MVP begins.

- FS needs to clarify with MVP that simply having the Plan of Development (POD) does not authorize MVP to perform work listed in the POD. FS agreed MVP should review Transcon's preconstruction checklist to make sure the proponent is aware of all of the required compliance.
- MVP first needs to provide FS with specific engineering plans and a road use permit
  application prior to any work on Pocahontas Road. FS needs to determine if this permit
  needs to be in place prior to tree felling or prior to construction.
- MVP submitted their draft NTP request to FS and BLM. Agencies and Transcon are
  providing comments back to MVP in order to improve the request. Once MVP submits an
  updated request, BLM's plan is to authorize pieces of the request as compliance is
  determined.
- MVP and Galileo met with EBCI and the Cherokee Nation to discuss tribal monitoring needs. EBCI is taking the lead with providing tribal monitors and has shared contact information with MVP. EBCI prefers periodic tribal monitoring when construction activity (including tree hauling) is happening around the site, but not during excavation of the site. MVP plans to hire tribal monitors as employees during construction around the site. MVP is coordinating with both tribes and the FS for requested scientific publications and presentations.
- The MVP construction phase kickoff call is scheduled for Tuesday, February 6<sup>th</sup> from 8 am to 5 pm local time. MVP is in charge of securing the meeting location.
- A project management detailer will replace Troy Morris as the project manager for MVP on Monday, February 5<sup>h</sup>.
