The Station Fire Recovery Area begins at the intersection of Little Tujunga Road and the boundary of the Angeles National Forest, Township 3 N, Range 14 W, Section 33, San Bernardino Base and Meridian; then continues north along Little Tujunga Road to the northern boundary of the Angeles National Forest, Township 3 N, Range 15 W, Section 1; then continues east along the boundary of the Angeles National Forest to its intersection with the western edge of Angeles Forest Highway, Township 4 N, Range 12 W, Section 2; then continues south along the western edge of Angeles Forest Highway to its intersection with Forest Road No. 4N20, Township 4 N, Range 12 W, Sections 11 and 12; then continues east along the southern edge of Forest Road No. 4N20 to its intersection with Forest Road No. 4N20A, Township 4 N, Range 11 W, Section 18; then continues south along the western edge of Forest Road No. 4N20A to the Desert Marksman Rifle Range, Township 4 N, Range 11 W, Section 18; then continues around the perimeter of the Desert Marksman Rifle Range to its intersection with Forest Road No. 4N20A, Township 4 N, Range 11 W, Section 18; then continues north along the eastern edge of Forest Road No. 4N20A to its intersection with Forest Road No. 4N20, Township 4 N, Range 11 W, Section 18; then continues west along the northern edge of Forest Road No. 4N20 to its intersection with Angeles Forest Highway, Township 4 N, Range 12 W, Sections 11 and 12; then continues north along the eastern edge of Angeles Forest Highway to its intersection with the Forest boundary, Township 4 N, Range 12 W, Section 2; then continues east along the Forest boundary to its intersection with the western edge of Forest Road No. 5N04.2 (Cheseboro Road), Township 5 N, Range 11 W, Section 28; then continues south along the western edge of Forest Road No. 5N04.2 to the locked gate, Township 5 N, Range 11 W, Section 34; then continues east to the eastern boundary of the Little Rock Reservoir, Township 5 N, Range 11 W, Section 34; then continues north along the eastern edge of the reservoir to the Little Rock Palmdale Dam, Township 5 N, Range 11 W, Section 27; then continues west along the Little Rock Palmdale Dam to the eastern edge of Forest Road No. 5N04.2, Township 5 N, Range 11 W, Section 27; then

continues north along the eastern edge of Forest Road No. 5N04.2 to the Forest boundary, Township 5 N, Range 11 W, Section 28; then continues east along the Forest boundary to its intersection with Forest Trail No. 10W02 (High Desert National Recreation Trail), Township 4 N, Range 10 W, Section 24; then continues south along Forest Trail No. 10W02 to its intersection with National Recreation Trail 2000.5 (Pacific Crest National Scenic Trail), Township 3 N, Range 10 W, Section 11; then continues west and south along National Recreation Trail 2000.5 to its intersection with Highway 2 (Angeles Crest Highway), Township 3 N, Range 10 W, Section 16; then continues east along Highway 2 to its intersection with Highway 39 (San Gabriel Canyon Road), Township 3 N, Range 9 W, Section 8; then continues south along Highway 39 to the West Fork Day Use parking lot and Trail Head, Township 2 N, Range 9 W, Section 19; then continues west around the perimeter of the West Fork Day Use parking lot and Trail Head, Township 2 N, Range 9 W, Section 19; then continues south on Highway 39 to the southern boundary of the Angeles National Forest, Township 1 N, Range 10 W, Section 14; then continues west along the Forest boundary to its intersection with Forest Road No. 2N41.1 (Santa Anita Canyon Road), Township 1 N, Range 11 W, Section 10; then continues north along Forest Road No. 2N41.1 to its intersection with National Recreation Trail 11W14 (Gabrielino National Recreation Trail), Township 1 N, Range 11 W, Section 3; then continues north along National Recreation Trail 11W14 to its intersection with Forest Trail No. 11W16 (Sturtevant Trail), Township 2 N, Range 11 W, Section 34; then continues west along Forest Trail No. 11W16 to its intersection with Forest Road No. 2N45 (Mt. Wilson Road), Township 2 N, Range 11 W, Section 29; then continues east and south along Forest Road No. 2N45 to its intersection with Forest Trail 12W16 (Idlehour Trail), Township 1 N, Range 11 W, Section 6; then continues northwest along Forest No. Trail 12W16 to its intersection with Forest Trail No. 12W14 (Sam Merrill Trail), Township 2 N, Range 12 W, Section 27; then continues south along Forest Trail No. 12W14 to its intersection with Forest Trail No. 12W14A, Township 2 N, Range 12 W, Section 34; then continues northwest along Forest Trail No. 12W14A to its intersection with Forest Road No. 2N50.2, Township 2 N, Range 12 W, Section 34; then continues west along Forest Road No. 2N50.2 to its intersection with Forest Trail No. 2N65.2 (Chaney Trail), Township 2 N, Range 12 W, Section 33; then continues south along Forest Trail No. 2N65.2 to the Angeles National Forest boundary, Township 2 N, Range 12 W, Section 33; then continues west along the Forest boundary to the starting point.
