### ***Grazing Restriction:***

No restrictions currently apply to this allotment.

### ***Allowable Use:***

The Decision dated 12/13/99 set guidelines for forage utilization in key areas of 35% allowable use during growing season and 40% during the dormant season. Within riparian areas that contain woody riparian plants, utilization is limited to no more than 25% of woody riparian sprouts/seedlings.

### ***Utilization Monitoring:***

Utilization monitoring will be conducted on or near key areas of your allotment. District personnel will monitor pasture use, and determine utilization percentage at that time. Monitoring dates will be set according to the previous year's monitoring results. If pastures were approaching allowable use during the 2009 grazing season they will be monitored at the mid-point of the pasture use period to determine if it is necessary for livestock to be moved to the next pasture in the rotation. Please note the following approximate dates that are scheduled for monitoring on the West Demetrio Allotment. You are encouraged to participate in monitoring utilization levels.

**2010 Monitoring Dates:**

Cabin Springs/Demetrio/Holding	2/24/11

If any one key area in a pasture being grazed by livestock exceeds utilization on the uplands or heavily hedging of woody riparian plant sprouts/seedlings, livestock will be moved to another area of the pasture where actual use is less than allowable use. If all remaining key areas in the grazed pasture are at allowable use, livestock will be required to be moved early to the next scheduled pasture. This requirement is necessary to prevent overuse on forage plants.

**Forage Growth and Water Availability:**

If forage growth and/or water availability are not adequate during all or portions of the 2010 grazing season, total or partial livestock removal from the allotment will be necessary. Part 2, clause 8(c) of the grazing permit provides this option.

**Range Developments:**

All assigned range developments identified in the Term Grazing Permit will be maintained to a functional status. Maintenance on the following developments are of high priority during the 2010 grazing season:

- Aspen Springs Pipeline
- Cabin Springs Pipeline
- Replace old storage and drinker at Candy Well

Please contact Stan or Monte before beginning these projects to complete required paper work.

**Other Information:**

As discussed, livestock will not enter the Aspen Springs pasture if there is not adequate water. Please remain in contact with District personnel to resolve these issues by 5/1/2010.

**Actual Use:**

Actual use for the 2009 grazing season was 840 AM's.
