## **Preface**

This Forest Land and Resource Management Plan (Forest Plan) has been prepared according to Secretary of Agriculture regulations (36 CFR 219) which are based on the Forest and Rangeland Renewable Resources Planning Act (RPA) as amended by the National Forest Management Act of 1976 (NFMA). The Forest Plan has also been developed in accordance with regulations (40 CFR 1500) for implementing the National Environmental Policy Act of 1969 (NEPA). Because the Forest Plan is considered a major Federal action significantly affecting the quality of the human environment, a detailed environmental impact statement has been prepared, as required by the National Environmental Policy Act. The Forest Plan represents the implementation of the Preferred Alternative as identified in the final environmental impact statement (FEIS) for the Forest Plan.

If any particular provision of this Forest Plan, or the application thereof to any person or circumstances, is found to be invalid, the remainder of the Forest Plan and the application of that provision to other persons or circumstances shall not be affected.
