

**UNITED STATES DEPARTMENT OF AGRICULTURE

SPECIAL RESTRICTION**

Pursuant to 16 U.S.C. Section 551, and Title 36 Code of Federal Regulations ("C.F.R."), Section 261.50(a) and (b) the following acts are prohibited in the Beaver Creek Nordic Ski Area on the Shoshone National Forest, Park County, Wyoming, Township 30 North, Range 100 West: Section 19 south of Highway 28, and all of section 30 (the "Restricted Area"). The Restricted Area is depicted on the attached map hereby incorporated into this Order as Exhibit A (the "Restricted Area"). This Order is in effect until June 1, 2010, or until rescinded, whichever event occurs first. The purpose of this order is to reduce user conflicts to ensure public health and safety.

PROHIBITIONS:

To go into or be upon the Restricted Area while using or possessing snowmobiles or other oversnow motorized vehicles. 36CFR 261.53(e)

EXEMPTIONS:

Pursuant to (36CFR 261.50(e) the following persons are EXEMPT from the order:

- (1) Any Federal, State or local officer, or member of an organized rescue or fire fighting force when in the performance of an official duty.
- (2) Any person with a Forest Service permit specifically authorizing the otherwise prohibited act or omission.

This Order rescinds, replaces, and supersedes any previous orders prohibiting the same acts covered by this Order in the above described Restricted Area.

Any violations of this Order is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six (6) months, or both. [Title 16, United States Code, Section 551, Title 18, United States Code, Section 3571(b) (6), Title 18 USC 3581 (b) (7)].
