## FOREST ORDER NO. 05-01-22-02 BOBCAT FIRE AREA, ROAD, AND TRAIL CLOSURE ANGELES NATIONAL FOREST

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to protect natural resources and provide for public safety, the following acts are prohibited within the Angeles National Forest. This Order is effective from April 1, 2022, through April 1, 2023.

- 1. Going into or being upon National Forest System lands within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
- 2. Being on any National Forest System Road within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A, shown on Exhibit B. 36 C.F.R. § 261.54(e).
- 3. Being on any National Forest System trail within the Angeles National Forest or San Gabriel Mountains National Monument as described in Exhibit A, shown on Exhibit B, and listed in Exhibit C. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Owners or lessees of land, to the extent necessary to access their land.
- 4. Permanent residents, to the extent necessary to access their permanent residences.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

## **EXHIBIT A**

The boundary of the Angeles National Forest Bobcat Closure Area begins at the intersection of the Angeles National Forest congressional boundary and Forest Trail No. 11W22 (Mt. Wilson Trail in Little Santa Anita Canyon) in section 9 of Township 1 North, Range 11 West, San Bernardino Base and Meridian (SBBM); then continues north along the eastern edge of the trail to the western edge of Section 9 of Township 1 North, Range 11 West, SBBM; then continues north along the section line to the southwestern corner of Section 21 of Township 2 North, Range 11 West, SBBM; then continues east along the section line to Mt. Wilson Road in Section 19 of Township 2 North, Range 11 West, SBBM; then continues west along the northern edge of Mt. Wilson Road to its intersection with California State Highway 2 (SR-2 Angeles Crest Highway) in Section 14 of Township 2 North, Range 11 West, SBBM; then continues east along the eastern edge of California State Highway 2 to its intersection with Forest Road No. 2N23 in Section 9 of Township 2 North, Range 11 West, SBBM; then continues east along the southern edge of Forest Road No. 2N23 to the intersection of Forest Road No. 2N21 in Section 36 of Township 1 North, Range 11 West, SBBM; then continues south along the western edge of Forest Road No. 2N21 to Clamshell Peak in Section 1 of Township 1 North, Range 11 West, SBBM; then continues south along the section line to the Angeles National Forest congressional boundary in Section 13 of Township 1 North, Range 11 West, SBBM; then continues west along the congressional boundary back to the starting point, as shown on Exhibit B.
