SPECIAL ORDER OF FOREST SUPERVISOR  
UINTA-WASATCH-CACHE NATIONAL FOREST  
PLEASANT GROVE RANGER DISTRICT

**TEMPORARY ROAD AND  
PARKING AREA CLOSURE**

**PROHIBITIONS:**

Pursuant to Title 36 CFR 261.50 (a) and (b) **the following acts are prohibited** on the National Forest System road and parking area as described in this order. The road and parking area affected are located on the Pleasant Grove Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting May 23, 2022 through June 3, 2022 or until further notice.

1. **Being in or being upon** Forest Service road #010 and the Horse Transfer Station parking area as described below and shown on attached map. This includes all motorized vehicles, pedestrian, hikers, equestrians, and bikers. [36 CFR 261.53(e)]

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

**AREA DESCRIBED:**

Forest Service road #010 is closed from the entrance of Forest road #085 to the entrance of Granite Flat campground including the horse transfer station parking lot located in Township 4 South, Range 2 East, Section 7 all within the Salt Lake Base Meridian, as shown on the attached map.

**PURPOSE:**

Purpose of the Closure is to provide for health and public safety due to construction hazards on Forest Service road #010.

**IMPLEMENTATION:**

1. This Order will be in effect when signed May 23, 2022 and shall remain in effect through June 3, 2022 or until further notice.
2. Attached map shows the roads affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b) (6), Title 18 USC 3581(b) (7)].
