**Boundary Description of Five River Segments**

**Portion of Segment "A" (Peter H. Dominick Wild River Area)  
within Rocky Mountain National Park**

**Poudre Lake  
To  
Rocky Mountain National Park Boundary**

This is a continuous description of the boundary of a portion of the Peter H. Dominick Wild River Area lying between the northern outlet of Poudre Lake within Rocky Mountain National Park to the intersection of the northern boundary of Rocky Mountain National Park being the southern boundary of the Comanche Peak Wilderness Area. All lands contained herein are intended to be within ¼ mile (1320 feet) of the mean high water line along both the east and west banks of the Cache la Poudre River and lying within Rocky Mountain National Park.

BEGINNING at the thread of the Cache la Poudre River at the northern outlet of Poudre Lake being south of Colorado State Highway 34, in Protracted Block 40, T. 5 N., R. 75 W., 6<sup>th</sup> P.M.;

thence southeasterly, along a line being perpendicular to the thread of the Cache la Poudre River, to the point of intersection with a line being 1320 feet southeast of and parallel to the mean high water line on the east bank of the Cache la Poudre River;

thence northeasterly along a line being 1320 feet parallel with the mean high water line on the east bank of the Cache la Poudre River to its intersection with the Chapin Creek;

thence northerly along a line being 1320 feet parallel with the mean high water line on the east bank of the Cache la Poudre River to its intersection with Hague Creek;

thence continue northerly along a line being 1320 feet parallel with the mean high water line on the east bank of the Cache la Poudre River to its intersection with northern boundary of Rocky Mountain National Park also being the southern boundary of the Comanche Peak Wilderness, P.L. 96-560, Roosevelt National Forest, a point near the section line between Secs. 25 and 36, T. 7 N., R. 75 W., 6<sup>th</sup> P.M.;

thence southerly along said boundary common to Rocky Mountain National Park and Roosevelt National Forest, being the same as the Comanche Peak Wilderness boundary, across the Cache la Poudre River to the point of intersection with a line being 1320 feet southwest of and parallel to the mean high water line on the west bank of the Cache la Poudre River in the NE1/4 of Sec. 1, T. 6 N., R. 75 W., 6<sup>th</sup> P.M;

thence southerly and southwesterly along a line being 1320 feet parallel with the mean high water line on the west bank of the Cache la Poudre River to its intersection with a line being 1320 feet from and perpendicular to the thread of the Cache la Poudre River at the northern outlet of Poudre Lake;

thence southeasterly along said perpendicular line to the POINT OF BEGINNING.

**Portion of segment "A" (Peter H. Dominick Wild River Area)**  
**within Roosevelt National Forest**

**Rocky Mountain National Park Boundary**  
**To**  
**Joe Wright Creek**

This is a continuous description of the boundary of a portion of the Peter H. Dominick Wild River Area lying between the southern boundary of the Comanche Peak Wilderness Area and the northern boundary of the Rocky Mountain National Park. All lands contained herein are intended to be within ¼ mile (1320 feet) of the mean high water line along the east and west bank of the Cache la Poudre River or along the Comanche Peak Wilderness boundary.

BEGINNING at a point where the thread of the Cache la Poudre River intersects the northwest boundary of the Comanche Peak Wilderness, P.L. 96-560, Roosevelt National Forest, in Sec. 28, T. 8 N., R. 75 W., 6<sup>th</sup> P.M.;

thence northeasterly, along the northwest boundary of the Comanche Peak Wilderness, to the point of intersection with a line being 1320 feet northeast of and parallel to the mean high water line on the east bank of the Cache la Poudre River;

thence southerly, along a line being 1320 feet parallel to the mean high water line on the east bank of the Cache la Poudre River, to the northwest boundary of Rocky Mountain National Park;

thence southwesterly along said Rocky Mountain National Park boundary across the Cache la Poudre River to the point of intersection with a line being 1320 feet west of and parallel to the mean high water line on the west bank of the Cache la Poudre River in the NE1/4 of Sec. 1, T. 6 N., R. 75 W., 6<sup>th</sup> P.M;

thence northwesterly, along a line being 1320 feet west of and parallel to the mean high water line on the west bank of the Cache la Poudre River, to the point of intersection with the boundary

of the Comanche Peak Wilderness boundary in the vicinity of a summit with a contour elevation of 9800 feet in the SW1/4 of the NE1/4 of Sec. 26, T. 7 N., R. 75 W., 6<sup>th</sup> P.M;

thence northwesterly along said Comanche Peak Wilderness boundary to a point, departing from said Comanche Peak Wilderness boundary, on a line being 1320 feet west of and parallel to the mean high water line on the west bank of the Cache la Poudre River, near the northerly end of Peterson Lake in the N1/2 of Sec. 22, T. 7 N., R. 75 W., 6<sup>th</sup> P.M;

thence northwesterly along a line being 1320 feet west of and parallel to the mean high water line on the west bank of the Cache la Poudre River to a point of intersection with the Comanche Peak Wilderness boundary approximately 700 feet east of a summit with approximately 9900 feet of elevation in the SW1/4 of the NE1/4 of Sec. 9, T. 7 N., R. 75 W., 6<sup>th</sup> P.M:

thence northerly along a ridge line being approximately ¼ mile west of and parallel to the mean high water line on the west bank of the Cache la Poudre River to the point of intersection with the westerly boundary of the Comanche Peak Wilderness on a summit with an elevation of 9,401 feet as described in the final Comanche Peak Wilderness description signed April 22, 1982 by Regional Forester Craig W. Rupp;

thence northeasterly along the Comanche Peak Wilderness boundary to the POINT OF BEGINNING.

**Segment “B” (Recreational River)**

This is a continuous description of the boundary of the Recreational Segment of the Main Fork of the Cache la Poudre River that lies between the easterly N-S boundary of the W1/2 of the SW1/4 of Sec. 1, T. 8 N., R. 71 W., 6<sup>th</sup> P.M. and the western boundary of the Comanche Peak Wilderness.

**South Fork of the Cache la Poudre River**  
**Icefield Pass**

**Rocky Mountain National Park Boundary**

This is a continuous description of the boundary of the wild river segment of the South Fork of the Cache la Poudre River lying between its source in the vicinity of Icefield Pass and the northern boundary of Rocky Mountain National Park being the southern boundary of the Comanche Peak Wilderness Area. All lands contained herein are intended to be within ¼ mile (1320 feet) of the mean high water line along both the east and west banks of the South Fork of the Cache la Poudre River and lying within Rocky Mountain National Park.

BEGINNING at the source of the South Fork of the Cache la Poudre River in the vicinity of Icefield Pass, near the section line between Secs. 1 and 12, T. 6 N., R. 74 W., 6th P.M.;

thence southeasterly to a point being perpendicular to and 1320 feet from the east high water line on the east bank of the South Fork of the Cache la Poudre River;

thence in a northwesterly, northerly and northeasterly direction along a line being 1320 feet parallel with the mean high water line on the east bank of the South Fork of the Cache la Poudre River to its intersection with the northern boundary of Rocky Mountain National Park also being the southern boundary of the Comanche Peak Wilderness, P.L. 96-560, Roosevelt National Forest, a point in Sec. 29, T. 7 N., R. 73 W., 6<sup>th</sup> P.M.;
