General Regulations:

- Vehicles must stay within 150 feet of a road
- No cutting of material >5 inches diameter in riparian areas
- No cutting allowed in the following areas:
 - o Campgrounds and administrative sites
 - o Non-Forest Service Land
 - o Timber Sale Areas (identified by paint-banded trees)
 - o Designated Wilderness Areas
 - o Within 200 feet of Logan Canyon Scenic Byway - US 89 Between First Dam and Wood Camp

Where you CANNOT cut

- Land not managed by the United States Forest Service outside of the Logan Ranger District.
- Administrative sites such as campgrounds, day use sites, and hiking trails. Heritage locations such as the Tony Grove Historical Nursery Area or Old Ephraim's grave.
- Research areas such as the T.W. Daniels Experimental Forest.
- The summer house area from First Dam to Wood Camp, along highway 89 in Logan Canyon.
- Protected areas such as federally designated wilderness, botanical areas, or range exclusion research plots.

Things to note

- Failure to provide permit upon being stopped by an agency representative or law enforcement officer will result in the surrender of the tree until a permit is produced.
- Trees and permits may not be resold.
- Permit holder assumes all liability for all resource damage that occurs from their party.
- Roads may not be plowed or maintained. Know the weather forecast, keep an eye on conditions, tell people where you are going and when you plan on being back, and know you and your vehicles abilities when choosing an area to find a tree. The United States Forest Service will not pull your vehicle out of the snow.
- Adverse weather conditions or emergencies may restrict access, and roads may or may not be plowed.
- Gates on the district are closed seasonally and operating a motor vehicle behind closed gates on closed roads will result in a citation. Walking or riding horses on a road closed to motorized use is allowed though. It is also allowed to operate a snow machine on these roads after sufficient snow has accumulated. For a list of roads or updates on closures please see the Motor Vehicle Use Map for the Logan Ranger District.

2024 CHRISTMAS TREE CUTTING REGULATIONS



Permits go on sale 11/4/2024 and are valid through 12/31/2024

*Permits may be purchased only through www.recreation.gov. Permits will not be available from the Logan Ranger District office or any other business. Permits cannot be resold.

What CAN be cut

- Any tree species except for the species Limber Pine, *Pinus flexilis*, may be taken. See "identifying limber pine" handout or contact the Logan Ranger Station for help.
- Any individual tree under 20 feet in height may be taken.
- Only one tree per permit is allowed and only one permit per household.

What CANNOT be cut

- Limber pines, and any species of tree over 20 feet tall (no topping is allowed).
- Do not cut within 200 feet of riparian areas (lakes and streams), roads, campgrounds, picnic areas, administrative sites, summer home areas, or within designated closed areas shown on the tree cutting maps.

Where you CAN cut

- Anywhere on the Logan Ranger District except as noted on the back page and the interior map.
