# **Access for Hunters with Disabilities**

## on the Rocky Mountain Ranger District

#### Helena - Lewis and Clark National Forest

The District Ranger has identified one (1) Forest Service Road on the Rocky Mountain Ranger District regarding access for hunters with disabilities, in consultation with representatives from the Russell Country Sportsman Organization.

This road, which has motorized restrictions starting on October 15, in accordance with the travel plan, is:

Hannan Gulch- Road #3305 (East of Y)

Hunters with disabilities must comply with Fish, Wildlife & Parks (FWP) access requirements to make use of access for hunters with disabilities on the Helena - Lewis and Clark National Forest.

Hunters with the *current year Permit to Hunt from a Vehicle* authorization <u>MUST BE</u> accompanied by another person to assist with field dressing and/or recovery of a wounded game animal when hunting big game. The **individual** accompanying the hunter with a disability may carry a firearm but is not authorized to shoot from a vehicle.

When necessary, hunters with disabilities that have the current year *Permit to Hunt from a Vehicle* or **Resident w/ a Disability Conservation License** may obtain combination lock information in <u>person</u> from the following offices:
