# Gifford Pinchot National Forest Approved Recreation Fee Changes

In 2022 the Gifford Pinchot National Forest solicited public feedback on proposed changes to recreation fees under the Federal Lands Recreation Enhancement Act. These changes included new fees, and fee increases, at multiple sites, and several special recreation permit fees (new and increase). The public comment period ended on October 07, 2022. Comments were collected and reviewed by U.S. Forest Service program managers and leadership.

Based on public feedback, some elements of the original Recreation Fee Proposal were modified. This modified proposal was brought forward to the current the Resource Advisory Committee (RAC) for recommendations March 9 and 10, 2023 to approve the proposed fee changes. The RAC members represent a broad array of recreation interest groups to help ensure that the Forest Service is proposing reasonable and publicly acceptable fee changes.
