SESPE CONDOR SANCTUARY
OCCUPANCY AND USE RESTRICTION

EXHIBIT A

The boundary of the Sespe Condor Sanctuary begins at the southeast corner of Township 5 North, Range 19 West, San Bernardino Base Meridian (SBBM); then continues northerly along the east boundary of the township to the northeast corner of said township; then continues westerly along the north boundary of the township to a point 1/8 mile east of Agua Blanca Creek; then continues southeasterly along Agua Blanca Creek at 1/8 mile distance north of the creek centerline to its intersection with the east edge of the township; then continues south 1/4 mile along said township; then continues northwesterly along Agua Blanca Creek at 1/8 mile distance south of the creek centerline to its intersection with the north edge of the township; then continues westerly and northerly following Agua Blanca Creek and Agua Blanca Trail (Forest Trail No. 19W10) at 1/8 mile distance south of creek/trail centerline, whichever is the most southerly, to the intersection of Bucksnot Trail (Forest Trail No. 19W18) and Agua Blanca Trail; then continues southwesterly following at 1/8 mile distance south of Bucksnot Trail approximately 1.5 miles to drainage divide between Stone Corral Creek and Agua Blanca Creek; then continues northwesterly and westerly along the divide between Stone Corral Creek and Agua Blanca Creek and divide between Stone Corral Creek and Alder Creek to its intersection with Alder Creek Trail (Forest Trail No. 20W11), approximately 1/2 mile east of Dripping Springs; then continues southerly at 1/8 mile distance east of Alder Creek Trail to intersection of Bucksnot Trail and Alder Creek Trail; then continues northerly at 1/8 mile distance west of Bucksnot Trail to drainage divide between Stone Corral Creek and Agua Blanca Creek; then continues easterly 1/4 mile; then continues southerly at 1/8 mile distance east of Bucksnot Trail and Alder Creek Trail to the wilderness boundary north of Dough Flat Trailhead; then continues westerly following the wilderness boundary 1/4 mile; then continues northerly at 1/8 mile distance west of Alder Creek Trail to its intersection with Alder Creek; then continues westerly and southerly at 1/8 mile distance south of Alder Creek to the intersection of Alder Creek and Sespe Creek; then continues southerly along Sespe Creek at 1/8 mile distance east of the creek centerline 9.3 miles to the south boundary of T5N R20W SBBM; then continues west across Sespe Creek to the west bank; then continues southerly along the west bank of Sespe Creek to a point 1/8 mile due south of the intersection of Sespe Creek and the mouth of Pine Canyon; then continues northerly along Sespe Creek at 1/8 mile distance west of the creek centerline for 9.7 miles to its intersection with the north boundary of T5N R20W SBBM; then continues westerly along the north boundary of the township to the northwest corner; then continues southerly along the west boundary of the township to the top of Topatopa Ridge; then continues southwesterly along the top of Topatopa Ridge to a point approximately one mile northeast of Hines Peak; then continues southeasterly along the top of the divide ridge between Santa Paula Creek and Sespe Creek to its intersection with the San Cayetano Trail in the north part of Section 8, T4N R20W SBBM; then continues easterly following the north side of San Cayetano Trail and San Cayetano Road to a point where the Road crosses San Cayetano Ridge on the north edge of Section 11, T4N R20W SBBM; then continues continuing northeasterly following the top of the ridge to its junction with Sespe Creek at the mouth of Pine Canyon; then continues northerly along Sespe

Creek at 1/8 mile distance west of the creek centerline to the south boundary of T5N R20W SBBM; then continues east along the southern boundary of Township 5 approximately 3/4 miles to the center of Section 36, T5N R20W SBBM; then continues north along the centerline of Sections 36 and 25 to its intersection with Tar Creek; then continues easterly along Tar Creek to its intersection with Forest Road No. 6N16.2; then continues northerly along the west side of Forest Road No. 6N16.2 to its intersection with Sespe Wilderness boundary west of Dough Flat Trailhead; then continues following Sespe Wilderness boundary clockwise around Dough Flat Trailhead to its intersection with Spring Canyon Trail; then continues easterly along Spring Canyon Trail to the section line between Sections 21 and 22, T5N R19W SBBM; then continues southerly following the section lines to the southwest corner NW1/4 SW1/4, Section 34, T5N R19W SBBM; then continues east 1/2 mile; then continues south 1/4 mile; then east following the south boundary of the township back to the starting point.
