



## Forest Order No. STF-16-2024-01

### Stanislaus National Forest Temporary Motor Vehicle Use Restrictions

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), and to provide for public safety, the following act is prohibited within the Stanislaus National Forest. This Order is effective from January 1, 2024, through December 31, 2024. This Order supersedes Forest Order STF-16-2023-13, executed July 5, 2023.

Using a motor vehicle on the following National Forest System Roads, also shown on Exhibits A through D:

#### **Calaveras District Roads (Exhibit A):**

- Forest Road No. 4N40

#### **Summit District Roads (Exhibit B):**

- Forest Road No. 5N95 from 1/2 mile north of the Middle Fork Stanislaus River Bridge to Intersection of 5N14
- Forest Road No. 5N05Y past the junction with 5N05YA to end
- Forest Road No. 5N09X past Mill Creek Bridge
- Forest Road No. 4N76Y

#### **Mi-Wok District Roads (Exhibits A, C):**

- Forest Road No. 2N11 from the 1N49 / 1N50 intersection to the 1N67 intersection
- Forest Road No. 1N01 from beginning of road wash out to 1N41
- Forest Road No. 1N01 from Hunter Creek to 1N02
- Forest Road No. 3N02 from 3N51Y to 3N15Y

#### **Groveland District Roads (Exhibits C, D):**

- Forest Road No. 2N14 from 1N04 to 3N01
- Forest Road No. 2S17Y from 1S16 to 2S83
- Forest Road No. 1S17 from Highway 120 to 1S36Y
- Forest Road No. 1S66 from 1S14 to 1S80
- Forest Road No. 1S08
- Forest Road No. 1S71 from Soldier Creek to End Mile Post
- Forest Road No. 1S03 from 1S04 to 1S78
- Forest Road No. 2S02 from 2S01 to 2S71
- Forest Road No. 1S32 from 1S19 to End Mile Post
- Forest Road No. 1N10 from Ferretti Road to South Fork Campground

- Forest Road No. 2S33 from 1S14 to 2S39
- Forest Road No. 2S30 from 1S70 to 1S11
- Forest Road No. 2S20 from 1S12 to intersection of 3S04 (Lower Forest Road No. 2S20)

36 C.F.R. § 261.54(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order; and
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A. A violation of this prohibition is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.
