**Abstract:** The Final Environmental Impact Statement documents the analysis of 10 alternatives which were developed to provide possible management direction for the 1.6 million acre Klamath National Forest. The Preferred Alternative emphasizes ecosystem health. Alternative Current/RPA is a continuation of present management direction. Alternative A emphasizes timber management. Alternatives B and B' emphasize visual quality and developed recreation.

Alternative C emphasizes maintaining diversity. Alternatives D and D' emphasize water quality and fish habitat. Alternative E emphasizes amenity values. Alternative G(SOHA) represents management practices prior to 1987. The selected alternative will become the forest plan and guide management of the Forest for the decade 1995 - 2005.
