Instead, the appraised value will be adjusted to reflect these cost estimates. Bids must reflect the costs of specified or prehaul road work and engineering services deposits.

In addition, we will continue offering timber contracts using stewardship authority. As in previous contracts, the value of timber will be exchanged for required service projects. Best Value Contracting will remain the method of technical proposal review and award.
