UINTA-WASATCH-CACHE NATIONAL FOREST
SPANISH FORK RANGER DISTRICT

AREA CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) and (b), **the following acts are prohibited** on the National Forest System road as described in this Order, all within the Spanish Fork Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect until further notice.

1. **Being within 1,000 feet of the construction area** as described below and shown on attached map. This includes all pedestrian, equestrian, bicycle and any type of motorized vehicles.
[36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

The area within 1,000 feet of the construction site including the Diamond Fork (Forest Road # 70029) beginning 800 feet south of the Hawthorne bridge on the south side and ending at the Sawmill Hollow trailhead on the north all located in Township 8 South, Range 5 East, Sections 2 and 11 all within the Salt Lake Meridian as shown on the attached map.

PURPOSE:

Purpose of the Closure is to provide for public health and safety while heavy equipment is being used to replace a bridge on the Diamond Fork road (Forest road #70029).

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7).
