**ROAD AND AREA CLOSURE**

**PROHIBITIONS:**

Pursuant to 16 USC 551 and Title 36 CFR 261.50 (a) and (b), the following acts are prohibited on the NFS roads and in the areas as described in this Order (the "restricted area") and as depicted on the attached map, hereby incorporated into this order as Exhibit A, within the Pecos/Las Vegas Ranger District, Santa Fe National Forest, Mora, San Miguel, and Santa Fe Counties within the state of New Mexico

1. Using any type of four-wheel motorized vehicles, two-wheel motorized vehicles, or all terrain vehicles (ATV's) on the restricted roads or within the restricted areas: snowmobiles are not prohibited. **36 CFR 261.54(a)** and **36 CFR 261.56**.

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50 (e), the following persons are exempt from this closure order:

1. Persons with a Forest Service permit specifically authorizing the prohibited act or omission.
2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Persons on snowmobiles.

**RESTRICTED AREA:**

The restricted area includes the entire length of all of the following Forest System Roads (FSR) on NFS land and the lands surrounding those roads as described by Township, Range, and Section: **FSR 18** (Mineral Hill) in its entirety (T16N, R14E, Sections 23 & 35), **FSR 156** (Johnson Mesa) in its entirety (T16N, R14E, Sections 13 & 23), **FSR 263** in its entirety (T16N, R14E, Section 14), **FSR 636** in its entirety (T19N, R14E, Sections 29 & 30), **FSR 637** in its entirety (T17N, R14E, Section 28), **FSR 113** in its entirety (T20N, R14E, Section 34), **FSR 114** in its entirety (T16N, R14E, Section 35), **FSR 18 JC** (San Geronimo) from Forest boundary in its entirety (T15N, R14E, Section 27), **FSR 634** (San Ignacio) from Forest boundary in its entirety (T17N, R14E, Section 20), **FSR 86** in its entirety (T 17N, R 12E, Sections 6, 26, 27, 32, & 33), **FSR 92** in its entirety (T17N, R12E, Sections 3,4,8,9,10,13,15,16,17,18,19,20,26,33,34, &35), **FSR 123** in its entirety (T17N, R12E, Section 29,30, & 32), (**FSR 123A** in its entirety (T17N, R12E, Section 32), **FSR 375** (Glorieta Baldy) in its entirety (T16N, R12E, Section 24), **FSR 645** (Willow Creek) in its entirety (T17N, R12E, Sections 19,20,21,24,25, & 30), **FSR 646** (Davis-Willow) in its entirety (T17N, R12E, Section 25,26,27,30,34,35, & 36), **FSR 555** to Jack's Creek Campground (Jack's Creek) in its entirety (T17N, R12E, Section 7), **FSR 305**

**PURPOSE:**

The purpose of this Order is for the protection of natural resources and infrastructure (including wildlife, watershed, and roads) and for the protection of public health and safety during extreme soil moisture and heavy snowfall periods.

**IMPLEMENTATION:**


1. This Order will be in effect from January 4, 2016 and shall remain in effect until April 9, 2016, or until the order is rescinded, whichever occurs first.
2. This order supersedes, rescinds and replaces all previous orders prohibiting the same acts covered by this order.
3. Any violation of this prohibition is punishable by a fine of not more than \$5,000.00 for individuals and \$10,000.00 for organizations, imprisonment for not more than 6 months, or both. (Title 16 USC 551, Title 18 USC 3571 and 3581).
