

Forest Order No. 06-16-01
Lassen National Forest
National Forest System Roads

Pursuant to 36 CFR 261.50(b) and 16 USC 551, and to provide for public safety and protect natural resources, the following acts are prohibited within the Lassen National Forest. For the purposes of this Order, a wheelchair is not considered to be a motor vehicle. This Order is effective from January 7, 2016, through March 31, 2016.

2. Using a wheeled motor vehicle on the Bizz Johnson Trail, from its intersection with Forest Road No. 30N07 (Westwood Junction), then southwest to its termination point at Mason Station Trailhead, as shown on Exhibit A.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 Part CFR 261, Subpart A.


A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 USC 551 and 18 USC 3559, 3571, and 3581.




Swain Mtn., Fredonyer and Bogard Winter Snowmobile Areas




