

FOREST ORDER**USDA FOREST SERVICE
GUNNISON NATIONAL FOREST
GUNNISON DISTRICT****East Brush Creek Winter Recreation Analysis Area**

Pursuant to 16 United States Code (U.S.C.) 551 and 36 Code of Federal Regulations (C.F.R.) 261.50(a) and 261.50(b), the following acts are prohibited within the described area on the Gunnison Ranger district of the Grand Mesa, Uncompahgre and Gunnison National Forests, Gunnison County, State of Colorado (the "Restricted Areas"), on roads located within the Restricted Areas (the "Restricted Roads") and on trails located in the Restricted Areas (the "Restricted Trails"), as depicted on the map hereby attached and incorporated into this Order as Exhibit A.

The Restricted Areas are further defined as the East Brush Creek Analysis area (T13S., R85W., Sections 24; T12S., R84W., Sections 31 and 32; T13S., R84W., Sections 5,6,7 and 18), west of Crystal Park and Hunter's Hill and 2) and the Lower East Brush Creek Analysis area (T13S., R85W., Section 24; T12S., R84W., Sections 6,7 and 18).

The purpose of this Order is to prevent conflicts of winter uses within East Brush Creek Analysis area.

PROHIBITIONS:

1. Using over snow motor vehicles on the Restricted Roads. § 261.54(a)
2. Using over snow motor vehicles on the Restricted Trails. 36 C.F.R. § 261.55(b)
3. Possessing or using over snow motor vehicles off National Forest System roads in the Restricted Area. 36 C.F.R. § 261.56

EXEMPTIONS:

Pursuant to 36 C.F.R. 261.50(e), the following persons are exempt from this order:

1. Any Federal, State or local officer, or member of an organized rescue or firefighting force in the performance of an official duty;
2. Persons with a Forest Service permit specifically authorizing the otherwise prohibited act or omission.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

This Order shall remain in effect until rescinded or until December 31, 2020, whichever event occurs first. This Order replaces, supersedes and rescinds Order No. 1999-06.


