## PROHIBITIONS

### **FOREST SUPERVISOR ORDER NO. 08-13-00-15-02 National Forest System Roads-Closed to All Users**

Pursuant to the provisions of 16 U.S.C., Section 551 and Title 36 CFR Part 261, Subpart B, the following acts are prohibited due to recent flood events for the protection of public health, safety, and natural resources.

**AFFECTED AREA:** All National Forests and Grasslands in Texas (NFGT) National Forest System (NFS) roads defined and shown as closed on the attached maps.

**EFFECTIVE DATES:** June 19, 2015 and until rescinded.

**PROHIBITED ACT:** No person or vehicle may enter, go into or be upon the NFS system roads defined and shown as closed on the attached maps.  
**36 CFR § 261.53(e) and § 261.54(e)**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission;
2. Any federal, state or local officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the General Prohibitions in 36 CFR Part 261, Subpart A.



# Davy Crockett National Forest National Forest System Roads Forest Supervisor Order No. 08-13-00-15-01






