2016 TEMPORARY POSITIONS (PHASE 3)



The Nez Perce-Clearwater National Forests in North Central Idaho will be filling multiple temporary (seasonal) positions for the upcoming 2016 field season. Openings may be available at the GS-2, GS-3, GS-4, and GS-5 levels and are for positions with a maximum six-month tour of duty (not to exceed 1,039 hours). The starting dates of the positions are anticipated to be between April and early June, 2016.

The Nez Perce-Clearwater National Forests encompass 4.0 million acres of beautiful and diverse land, located in North Central Idaho. From the dry, rugged canyons of the Salmon River to moist, cedar forests of the Selway drainage, and the rolling uplands of the Palouse, the Nez Perce-Clearwater National Forests offer something for everyone.

This vast, diverse area is managed to provide a variety of goods and services including breathtaking scenery, wilderness, wildlife, fisheries, timber harvest, livestock grazing, mining, pristine water quality and a wide array of recreation opportunities.

The Forests are best known for their wild character. Nearly half of the Forests' lands are designated as Wilderness and include large segments of wild and scenic river designations along the Selway, Lochsa and Salmon Rivers; three rivers popular with thrill-seeking floaters and fishing enthusiasts.
