The 2012 Planning Rule (36 CFR 219) requires the Deschutes National Forest to establish a land management transition monitoring plan that is consistent with the new Planning Rule's monitoring requirements by May 9, 2016, or as soon as practicable. We have reviewed our existing Deschutes Land and Resource Management Plan (Forest Plan) monitoring plan and developed modifications to conform to the new monitoring requirements.

We want to take this opportunity to share our draft transition monitoring plan with you and, consistent with our government-to-government relationship, request your input. Your input would be most helpful to us in finalizing the monitoring plan if we receive it by March 15, 2016.

The 2012 Planning Rule includes eight monitoring requirements where at least one monitoring question and indicator is established for each of the eight requirements and they are as follows:

- i. The status of select watershed conditions.

evaluate whether Forest Plan components are effective and appropriate, and whether management is being effective in maintaining or achieving progress toward the desired conditions and objectives for the Forest.

The first Deschutes National Forest monitoring report under the updated monitoring plan is expected to be published in 2018.
