GENERAL INFORMATION:

1. Note: Provide your **TAX IDENTIFICATION NUMBER (TIN) in the signature block of the bid form.**
2. Contract provision B(T)8.64 – Debarment and Suspension Certification (6/06) requires Purchasers to obtain certifications from its lower tier participants regarding debarment, suspension, ineligibility and voluntary exclusions after award of the contract. Purchasers shall keep the certifications on its lower tier covered transactions on file until sale termination date, and will provide a copy to the Forest Service at the written request of the Contracting Officer. An example of this certification is shown following the instructions for page 101 of this contract.
3. Corporations submitting an offer under this solicitation must include form AD-3030-FS Representation Regarding Felony Conviction and Tax Delinquent Status For Corporate Applicants.
4. A Prework conference is required annually before the commencement of work. The Purchaser shall arrange for this meeting with the Contracting Officer (C6.10).
5. As per B4.213, Periodic Payment Schedule, periodic payment will be required. The approximate periodic payment date is 12/19/2016. The final date will be based on the award date of this timber sale.
6. Unit 18 is Timber Subject Agreement (C2.11#). This unit will only be included upon written agreement between Forest Service and Purchaser. This unit is also described as a Special Treatment Area (STA), which requires no skidding or yarding equipment allowed to operate within the area. Merchantable products shall be winched from outside the area to the existing road (C6.4#).
7. Slash Disposal Deposit will be paid by Purchaser by lump sum payment, by cutting unit upon completion of skidding activities (C4.228#).
8. Road Maintenance and Surface Replacement Deposits were calculated by the total volume of both Sawtimber and Non-sawtimber.
9. Washing of equipment prior to entering the Sale Area is required in order to prevent the spread of noxious weeds (C6.351#), an allowance for this is NOT made in the appraisal.
10. High use roads are required to be kept open to public travel, as per Sale Area Map.
11. See C6.316#-Limited Operating Period for timing constraints for Unit 20.
12. This sale will be sold by the ton and 100% weight scaled with split pricing for Sawtimber and Non-Sawtimber.
13. The environmental document that approved this sale is the Valley Face Fuels Reduction Project Decision Notice Signed October 31, 2006.
14. The Hazardous Reduction and Site Preparation Plan (C6.7#) requires excavator piling of fuels within 100 feet of private property boundaries for Units 20 and 401.
