**52.222-99, ESTABLISHING A MINIMUM WAGE FOR CONTRACTORS (DEVIATION 2014-0001)
(October 2014)**

This clause implements Executive Order 13658, *Establishing a Minimum Wage for Contractors*, dated February 12, 2014, and OMB Policy Memorandum M-14-09, *Implementation of the President's Executive Order Establishing a Minimum Wage for Contractors*, dated June 12, 2014.

(a) Each service employee, laborer, or mechanic employed in the United States (the 50 states and the District of Columbia) in the performance of this contract by the prime Contractor or any subcontractor, regardless of any contractual relationship which may be alleged to exist between the Contractor and service employee, laborer, or mechanic, shall be paid not less than the applicable minimum wage under Executive Order 13658. The minimum wage required to be paid to each service employee, laborer, or mechanic performing work on this contract between January 1, 2015, and December 31, 2015, shall be \$10.10 per hour.

(b) The Contractor shall adjust the minimum wage paid under this contract each time the Secretary of Labor's annual determination of the applicable minimum wage under section 2(a)(ii) of Executive Order 13658 results in a higher minimum wage. Adjustments to the Executive Order minimum wage under section 2(a)(ii) of Executive Order 13658 will be effective for all service employees, laborers, or mechanics subject to the Executive Order beginning January 1 of the following year. The Secretary of Labor will publish annual determinations in the Federal Register no later than 90 days before such new wage is to take effect. The Secretary will also publish the applicable minimum wage on www.wdol.gov (or any successor website). The applicable published minimum wage is incorporated by reference into this contract.

(c) The Contracting Officer will adjust the contract price or contract unit price under this clause only for the increase in labor costs resulting from the annual inflation increases in the Executive Order 13658 minimum wage beginning on January 1, 2016. The Contracting Officer shall consider documentation as to the specific costs and workers impacted in determining the amount of the adjustment.

(d) The Contracting Officer will not adjust the contract price under this clause for any costs other than those identified in paragraph (c) of this clause, and will not provide price adjustments under this clause that result

in duplicate price adjustments with the respective clause of this contract implementing the Service Contract Labor Standards statute (formerly known as the Service Contract Act) or the Wage Rate Requirements (Construction) statute (formerly known as the Davis Bacon Act).

- (e) The Contractor shall include the substance of this clause, including this paragraph (e) in all subcontracts.

If this contract is completely or partially terminated, the records relating to the work terminated shall be made available for 3 years after any resulting final termination settlement. Records relating to appeals under the disputes clause or to litigation or the

settlement of claims arising under or relating to this contract shall be made available until such appeals, litigation, or claims are finally resolved.

(3) As used in this clause, records include books, documents, accounting procedures and practices, and other data, regardless of type and regardless of form. This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

STATEMENT OF WORK

Introduction

In the Lucky Peak Nursery Greenhouse, often multiple seeds are sown into each cell of a styroblock/plastic tray, the container in which seedlings are grown. Now that the seeds have been sown and the plants are coming up, we need to pull out all but one plant in each cell. This document explains the need for contract help and how the process should be done. The Table below shows the number of blocks to be thinned and the intended number of seeds put in each cell. The target number of seeds per cell does not mean there will be two seedlings in every cell. Some cells probably received more and some received less than intended. It is recommended that interested bidders inspect the LPN greenhouse before submitting a bid.

Scope

In all, 17,300 styroblocks/Plastic trays need to be thinned. These blocks contain 45, 77, 112, 128, or 91cells (see table below). The blocks are on rolling benches in the green house. There are ten species of trees, ponderosa pine, lodgepole pine, Engelmann spruce, Corkbark fir and Douglas-fir, Blue spruce, sagebrush, bitterbrush, SW white pine, and some native forbs. Sowing will take place from Feb. 8th through Feb. 12th, March 14, through March 25th and May 9nd, through May 20th. Most of the blocks will be sown with 2 seeds however the range will be from 1 to 5 and the actual number of emerged seedlings depends upon the germination rates of each source. The table below tells how many blocks per species will be done and the range in number of seeds sown. Thinning will begin about one month after sowing.

The task for the contract crew is to remove all but one plant from each cell without damaging the remaining plant. In the sagebrush, it is acceptable to leave 2 seedlings in a cell. Damage is regarded as breaking the stem or top, partially removing the plant from the soil, an empty cell where one or more plants stood before thinning, or anything else that will lead to death or slowed growth. In addition, the contractor should pull any weeds that are found growing in the cells.

The contract crew will have access to the green house from 7:00 until 5:00, Monday through Friday for the duration of the contract. Bids should be in the form of price per block.

Thinning process:

1. Pull out all but one plant per cell.
2. Leave the healthiest plant (the plant most likely to succeed).
3. If they look to be of equal health, leave the most mature plant.
4. If maturity is equal, leave the plant closest to the center of the cell.
5. Leave the remaining plant unharmed.
6. Remove any weed from all cells.
7. Discarded plants should be place in a dumpster provided.

Access

The blocks are located on rolling pallet benches in the Lucky Peak Nursery greenhouse, 15169 E. Highway 21, Boise, Idaho 83716. The facility is approximately 17 miles northeast of Boise on Highway 21. Access into the crop is achieved by rolling out benches and standing in the space in between pallets. **Pallets should be returned to their original position at the end of each day.** It is best to use two people to roll the pallets. The nursery is open for work between the hours of 7:00 AM and 5:00 PM, Monday through Friday.

Inspection

Lucky Peak Nursery Personnel will check random sample blocks shortly after the contractor has finished a section. The results will be shared immediately with the contractor so that they will know how well they are doing and make changes if necessary.

No incentive pay will be given.

- 2) After contract award, the contractor prepares a written report listing in order the proposed classification title(s), a Federal grade equivalency (FGE) for each proposed classification(s), job description(s), and rationale for proposed wage rate(s), including information regarding the agreement or disagreement of the authorized representative of the employees involved, or where there is no authorized representative, the employees themselves. This report should be submitted to the contracting officer no later than 30 days after such unlisted class(es) of employees performs any contract work.
- 3) The contracting officer reviews the proposed action and promptly submits a report of the action, together with the agency's recommendations and pertinent information including the position of the contractor and the employees, to the Wage and Hour Division, U.S. Department of Labor, for review (See 29 CFR 4.6(b)(2)(ii)).
- 4) Within 30 days of receipt, the Wage and Hour Division approves, modifies, or disapproves the action via transmittal to the agency contracting officer, or notifies the contracting officer that additional time will be required to process the request.
- 5) The contracting officer transmits the Wage and Hour decision to the contractor.
- 6) The contractor informs the affected employees.

Information required by the Regulations must be submitted on SF-1444 or bond paper.

When preparing a conformance request, the "Service Contract Act Directory of Occupations" (the Directory) should be used to compare job definitions to ensure that duties requested are not performed by a classification already listed in the wage determination. Remember, it is not the job title, but the required tasks that determine whether a class is included in an established wage determination. Conformances may not be used to artificially split, combine, or subdivide classifications listed in the wage determination.

(b) *Options*. The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. The Government may determine that an offer is unacceptable if the option prices are significantly unbalanced. Evaluation of options shall not obligate the Government to exercise the option(s).

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those
