ORDER OF FOREST SUPERVISOR
ORDER NUMBER 14-01-2016

Under the authority of the Act of Congress dated June 4, 1897, as amended (16 U.S.C. 551), and pursuant to the Secretary of Agriculture's Regulations set forth as 36 CFR Part 261, Subpart B (36 CFR 261.50(a) and (b)), the following acts and omissions are prohibited on the Wayne National Forest, Ironton Ranger District, located within the State of Ohio. Said areas are shown on the maps set forth as Exhibit A, which is attached and made a part hereto:

1. Go onto, enter, be upon, or use any portion of the Telegraph, Lyra, Wolcott or Superior trails which have been posted closed 36 CFR 261.53(e).


THESE RESTRICTIONS ARE NECESSARY FOR PUBLIC SAFETY AND TO PROTECT NATIONAL FOREST PROPERTY/RESOURCES. THEY ARE IN ADDITION TO THE GENERAL PROHIBITIONS SET FORTH IN 36 CFR PART 261. THE PROHIBITION WILL BE IN EFFECT FROM THE DATE OF THIS ORDER UNTIL SPECIFICALLY WITHDRAWN BY TERMINATION ORDER OF THE FOREST SUPERVISOR.

Pursuant to the provisions of 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission (36 CFR 261.50(e)(1)); and,
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty (36 CFR 261.50(e)(4)).

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.



Map 1 of 3




