


Maps 14 and 15 Walla Walla RD


EXPLANATION OF LEGEND ITEMS

- Roads Open to Highway Legal Vehicle Only:**
These roads are open only to motor vehicles licensed under State law for general operation on all public roads within the State.
- Roads Open to All Vehicles:**
These roads are open to all motor vehicles, including smaller off highway vehicles that may not be licensed for highway use (but not to oversize or overweight vehicles under State traffic law).
- Trails Open to All Vehicles:**
These trails are open to all motor vehicles, including both highway legal and non highway legal vehicles.
- Trails Open to Vehicles 50" or Less in Width:**
These trails are open only to motor vehicles less than 50 inches in width at the widest point on the vehicle.
- Trails Open to Motorcycles Only:**
These trails are open only to motorcycles. Sidecars are not permitted.
- Special Vehicle Designation:**
This symbol indicates that the road or trail is open to classes of vehicles other than those listed above. Refer to the Seasonal and Special Designation Table for further instructions.


