

Philson Crossroads Rifle Range



Four year-round rifle ranges are located on the Enoree Ranger District: Fairforest, Indian Creek, Leeds and Philson Crossroads. All four ranges have been designed with the firearm enthusiast in mind. All rifle ranges have six shooting tables under a shelter, are open year-round for day use, and do not have fees.

Philson Crossroads is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

Fairforest is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

Indian Creek is ADA accessible, with paved paths to targets and accommodates targets at 25 and 100-yard intervals.

Leeds is ADA accessible and accommodates targets at 25 and 100-yard intervals.

Directions

At Interstate 26 and Hwy. 56, drive north 0.5 miles. Turn right at Hwy. 56 and 44-22, Barrel Stave Rd, drive 3.9 miles. Turn right at 44-22 and State Highway S-30-26, Philson Rd. drive 0.4 miles. Turn left at Philson Rd and Forest Service Rd. 7009 and drive 0.2 miles to rifle range.

At Hwy. 49 and Jones Ford Rd. 44-22 turn right and drive 0.3 miles to four-way stop. At intersection of Jones Ford Rd. 44-22 and 44-18, drive south 6.4 miles. Turn left at 44-22 and State Hwy. S-30-26, Philson Rd., and drive 0.4 miles. Turn left at Philson Rd. and FS Rd. 7009 and drive 0.2 miles to the rifle range.

Regulations


- All weapons must meet South Carolina firearm safety standards. See <http://www.dnr.sc.gov> for more details.
- No alcoholic beverages
- No tracer or incendiary ammunition
- Skeet and trap shooting is not permitted
- Shoot only at paper targets mounted on self-provided stands or holders.
- Shoot only from the firing line, downrange and into the backstop
- Shooters under the age of 16 must be accompanied by adult
- Properly dispose of litter, including target


