

**Piling of Fuels, Hand or Machine -Roadside Clean-up**

Purchaser is responsible for the roadside clean up (Mechanical Piling) within 20 feet from the edge of all system roads adjacent to subdivisions. The machine used to grapple pile the slash shall stay on the road surface.

Purchaser Responsibility estimated costs = \$650/acre x 6 acres = \$3,900

FS will be responsible for covering and burning the piles, cost is included under **Burning of Piled Material** (see bullet above)

**Brush Disposal Treatment Plan Narrative Statement**

- **Fuels Inventory**

Conduct post-harvest fuels inventories on all Units (total of 81 acres) for the preparation of the Burn Plan for each unit requiring prescribed burning in accordance with the silvicultural prescription.

$\$54.65/\text{acre} \times 81 \text{ acres} = \$4,426$  (includes 10.00% Forest Collection Rate and 2% Inflation Rate)

- **Burning of Piled Material**

Conduct covering and burning of yarded un-merchantable material resulting from the yarding operation at all landings as well as purchaser created roadside clean-up piles. Piles will be burned in units: 1, 2, 3, 9, 11, 12, 14a, 14b, 16, 17, 18, 19, 19a, 25, 26, 27 and 27a.

$\$384.02/\text{acre} \times 6 \text{ acres} = \$2,304$  (includes 10.00% Forest Collection Rate and 2% Inflation Rate)
