***AREA CLOSURE
(For Public Safety)***

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) the following act is prohibited on National Forest lands described in this order, all within the Idaho City Ranger District, Boise National Forest each day from 8:00 A.M. to 8:00 P.M. May 18 – 20, 2016 and beginning at 12:01 A.M. May 23, 2016 to 6:00 P.M. May 27, 2016 (24 hour closure each day May 23-27, 2016).

1. Going into or being upon the area (as described below). **36 CFR 261.53(e)**

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with a special use authorization (Timber Sale Contract) or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.
4. NFS Road #314 (Bear Run Road) will remain open.

LYKOW FLATS AREA DESCRIBED:

All National Forest System (NFS) Land within 500 feet outside of the following boundary and all lands within the following boundary (including all roads and trails within the boundary); beginning at the junction of NFS Roads #314 (Bear Run) and #314C (Varga Link); continuing North along NFS Road #314 to the junction of NFS Roads #314 and #314B (Bear Loop Run); continuing West becoming South along NFS Road #314B to the junction of NFS Roads #314B and 314D1; continuing Southwest along NFS Road #314D1 to the junction of NFS Roads #314D1 and #314D (Rear Link); continuing South along NFS Road #314D to the junction of NFS Roads #314D and #314C; continuing Northwesterly along NFS Road #314C back to the point of origin. All lands are within Township 6 North, Range 5 East, Section 13 and Township 6 North, Range 5 East, Sections 18 and 19, Boise Meridian.

The above described area is within the Idaho City Ranger District, Boise National Forest, Boise County, Idaho.


PURPOSE:

Fire personnel will be training in the above described Lykow Flats Area. The Area described is closed to all public entry to provide for public health and safety due to training being conducted.

IMPLEMENTATION:

1. This Order will be in effect each day from 8:00 A.M. to 8:00 P.M. May 18 – 20, 2016 and beginning at 12:01 A.M. May 23, 2016 to 6:00 P.M. May 27, 2016 (24 hour closure each day May 23-27, 2016).
2. A map identifying the area closure is attached and made part of this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for an organization, and/or imprisonment for not more than six (6) months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581 (b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the areas (and/or roads, trails) covered by this Order.
