Alcoholic Beverages No Longer Allowed in Day-Use Areas containing swim beaches on Kisatchie National Forest

A new regulation for the Kisatchie National Forest will be in effect this summer for all day use areas with a swim beach. No alcoholic beverages will be allowed in swimming areas which include Kincaid Lake, Stuart Lake, and Caney Lakes. Other sites including campgrounds are not affected by this change.
