On 06/14/2016, at 11:00 AM, sealed bids will be opened in the Yreka, California for the Tyler Meadows Fire Salv Re-Offer II sale. This sale is located in T44N, R12W, sec 1 & 2; T45N, R12W, sec 23-27,34-36; T45N, R11W, sec 19; MDBM; Siskiyou County. Timber sale Contract 2400-6 will be used. The termination date for this sale is 12/31/2016.

Measurement of the estimated quantities will be made after felling. The total estimated quantity on this sale is 6,739 MBF. The Forest Service encourages potential bidders to make their own inspection and estimate prior to bid submission. The Forest Service makes no representation, warranty, or guarantee of the accuracy of the following quantity estimates:

The minimum acceptable bid for advertised timber is \$3,369.50 for the biddable species.

There is a \$400.00 bid guarantee required on this sale.

This sale is being re-offered a second time under a 7 day advertisement period. The only change in this re-offer is that the helicopter units are now Timber Subject to Agreement (TSTA). Prospective bidders are encouraged to review the sale area and all documentation prior to submission of bid(s).

The sale area is within a Forest Closure Order (No. 15-05-771). Prospective bidders will need to contact the Forest Supervisor's Office in Yreka or one of the westside District Offices to obtain a key and permit to access the area.

The purchaser of this sale will be required to meet the requirements in the California Regional Water Quality Control Board Waiver. A copy of the waiver can be found on the Klamath National Forest website at www.fs.usda.gov/klamth. Other documentation and information on the sale may also be found at the Klamath National Forest website.

This sale includes Surface Replacement Deposits, C5.35# (Road and Water Supply Use). Deposits will be charged at a rate of \$2.13 per mbf.

The cruise volume was adjusted manually outside of the actual cruise file. There is a BF-CF volume adjustment worksheet that indicates the original cruise volume and the reduced revised volumes for the contract. A description of how the reduced volume was calculated is located in the prospectus, in addition to a brief description in the BF-CF adjustment worksheet.
