SPECIAL ORDER OF FOREST SUPERVISOR
UINTA-WASATCH-CACHE NATIONAL FOREST
SALT LAKE RANGER DISTRICT

TEMPORARY ROAD CLOSURE

PROHIBITION:

Pursuant to 36 CFR 261.50(a) and 36 CFR 261.50(b), **the following acts are prohibited** on the National Forest System road described in this order. The road affected is located on the Salt Lake Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect from June 15, 2016 through July 10, 2016.

1. **Being in or upon the road with any type of motorized vehicle** as described below and shown on attached map. [36 CFR 261.53(e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

1. Persons with a permit specifically exempting them from the effect of this order.
2. Any Federal, state or local officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIPTION:

The Albion Basin road (Forest Service Road 028) beginning at the gate just passed the Information Booth at Alta to the Albion Basin campground and the Cecret Lake road (Forest Service Road #270) from the Albion Basin campground to the Cecret Lake trailhead, located in Township 3 South, Range 3 East, Sections 5, 4, and 9, all within the Salt Lake Base Meridian. As shown on the attached map.

PURPOSE:

Purpose of the closure is to provide for public health and safety during road maintenance that includes grading, culvert cleaning and dust abatement (application of magnesium chloride).

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].

5. This Order supersedes any previous Order(s) prohibiting the same, or similar acts prohibited by this Order in the area covered by this Order.
