To Whom it May Concern:

Please accept this letter as official delegation of authority for tribal representation on wildland fire incidents occurring during the 2015 fire season. The Designated Tribal Government Representatives are identified on the attached Government to Government Fire Management Coordination Form. This Delegation is concerning governmental cooperation, coordination, and expedited consultation concerning wildland fire incidents and prescribed fire activities as applicable.

The Identified Designated Tribal Government Representative(s), are delegated the authority to be the point of contact for expedited incident consultation during the course of wildland fires events, and prescribed fires/cultural burns as applicable on behalf of the Karuk Tribe.

If unresolved issues arise during the course of an incident or activity, such representative assigned will confer the situation with the Tribal Council and Self-Governance Coordinator for the purposes of determining any appropriate course of action in relation to or beyond the scope of the Fire MOU and this Delegation of Authority.

Thank you for your dedication to cooperation, coordination, and consultation in the interest of achieving mutual benefit in relation to wildland fire management, and prescribed fire activities.
