Forest Supervisor's Order

Pursuant to Title 36 Code of Federal Regulation 261.50(a) and (b), the following acts are prohibited on the Areas, Roads, and Trails within the Beaverhead-Deerlodge National Forest.

**Rationale:**

This Special Order implements the February 12, 2010 Record of Decision Enacting the Forest Plan Travel Management Direction for Certain Areas of the Beaverhead-Deerlodge National Forest. These Areas, Roads, and Trails are closed to provide quiet recreation opportunities and to provide and protect wildlife security and winter ranges.

**36 CFR 261.54(a).**

1. It is prohibited to use any motorized vehicle on ROADS not designated as OPEN to such use.

**36 CFR 261.55(b).**

2. It is prohibited to use any motorized vehicle on TRAILS not designated as OPEN to such use.

**36 CFR 261.56.**

3. Motorized vehicle use is prohibited off roads and trails within the restricted areas.

**36 CFR 261.55(b).**

4. Wheeled or motorized vehicles designed for the primary purpose of transporting people, excluding wheelchairs, are restricted within recommended wilderness areas.

**Location/ Specific Area Descriptions:**

The above restrictions are indicated and described within the:

-Beaverhead-Deerlodge National Forest Travel Map/Plan (Attached addendum maps)

-February 10, 2010 Record of Decision Enacting the Forest Plan Travel Management Direction for Certain Areas of the Beaverhead-Deerlodge National Forest.

- January 14, 2009 Record of Decision and Revised Beaverhead-Deerlodge National Forest Land and Resource Management Plan

**Dates of Restrictions:**

These travel prohibitions are in effect yearly:

- From May 16 through December 1 within the Designated Summer Non-Motorized allocations.
- From December 2 through May 15 in the Designated Winter Non-Motorized allocations.
- Yearlong within the Designated Recommended Wilderness areas.

These restrictions shall remain in effect until rescinded.


**Exemptions:**

Pursuant to Title 36 CFR 261.50(e), the following are exempt from this restriction:

1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.

2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

**Penalty:**

Violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC 551 and 18 USC 3559 and 3571).
