On 08/09/2016, at 11:00 AM, sealed bids will be opened in the Forest Supervisor's Office, Attn: Timber Mgmt., Room 238D, P.O. Box 1270, Hot Springs, AR 71902 for the Rodeo sale. This sale is located in T2S, R24W, Sections 19, 20, 28, 29, 30; T2S, R25W, Sections 33, 34; and T3S, R25W, Section 3; Compartments 1633, 1639, 1640, 1648; Montgomery County, Arkansas. Timber sale Contract 2400-6T will be used. The termination date for this sale is 10/31/2020.

There are 0.54 miles (0.87 kilometers) of specified road reconstruction. A specified road construction cost of \$28,410.00 has been allowed in the appraisal for this work.

The estimated quantities in this contract have been determined prior to felling. The total estimated quantity on this sale is 5,762 CCF.
