TEMPORARY TRAIL CLOSURE

PROHIBITIONS:

Pursuant to Title 36 CFR 261.50(a) and (b), **the following acts are prohibited** on the National Forest System road described in this Order. All lands affected are located on the Heber/Kamas Ranger District, Uinta-Wasatch-Cache National Forest. This order is in effect starting July 12, 2016 through September 23, 2016.

1. **Being in or upon the Mirror Lake Shoreline trail** (Forest Service trail #225) as described below. [36 CFR 261.53 (e)]

EXEMPTIONS:

Pursuant to 36 CFR 261.50 (e) the following persons are exempt from this order:

1. Persons with special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in performance of an official duty.

AREA DESCRIBED:

Mirror Lake Shoreline trail (Forest Service trail #225) located Township 1 South, Range 9 West, Sections 34 and 27 all located in the Salt Lake Base Meridian as shown on map.

PURPOSE:

Purpose of the closure is for public health and safety while crews are executing heavy repairs and reconstruction work along the trail, which includes running 4-5 pieces of heavy equipment, and hauling multiple tons of road base and supplies with OHV's hauling trailers, which makes the trail unsafe for use.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect until further notice.
2. Attached map shows the area affected by this Order.
3. Violation of the above prohibition(s) is punishable by a fine of not more than \$5,000 for an individual, or \$10,000 for an organization and/or imprisonment for not more than 6 months. [Title 16 USC 551, Title 18 USC 3571(b)(6), Title 18 USC 3581(b)(7)].
