

# PUBLIC NOTICE

## TAHOE NATIONAL FOREST RED STAR RIDGE CAMPING RESTRICTION ORDER NO. 17-95-168

PURSUANT TO 36 CFR 261.50(a), I HEREBY PROHIBIT THE FOLLOWING ACT ON THAT PORTION OF THE FORESTHILL RANGER DISTRICT SHOWN ON EXHIBIT 1 AND COMMONLY KNOWN AS RED STAR RIDGE:

CAMPING FROM SEPTEMBER 15 THROUGH NOVEMBER 15 OF EACH YEAR. 36 CFR 261.58(e).

PURSUANT TO 36 CFR 261.50(e)(1)(4), THE FOLLOWING PERSONS ARE EXEMPT FROM THIS ORDER:


1. ANY FEDERAL, STATE, OR LOCAL OFFICER, OR MEMBER OF AN ORGANIZED RESCUE OR FIRE FIGHTING FORCE IN THE PERFORMANCE OF AN OFFICIAL DUTY.
2. PERSONS WITH A PERMIT WHICH SPECIFICALLY AUTHORIZES CAMPING IN THE RED STAR RIDGE AREA. THIS PERMIT MUST BE IN THE PERSON'S POSSESSION WHILE CAMPING.

THE EXTERIOR BOUNDARIES OF THE RED STAR RIDGE RESTRICTED AREA ARE AS SHOWN ON EXHIBIT 1; GENERALLY DESCRIBED AS:

Beginning at the Duncan Diversion Dam on Duncan creek (SW 1/4, NW 1/4, Sec. 24, T.15 N., R.13 E., MDM.), proceed East, approximately one and three-quarter miles to the boundary of the State Game Refuge on top of Red Star Ridge (Center of Sec. 19, T.15 N., R.14 E., MDM.). Then proceed Southerly along the State Game Refuge Boundary to its intersection with Mosquito Ridge road (FH96). Then Eastbound on Mosquito Ridge road approximately one half mile to the Section Corner common to Sections 25, 26, 35, 36, T.15 N., R.13 E., MDM.). Then Southeast along the Section line common to Sections 35 and 36 to the Middle Fork of the American River. Then Southwesterly along the Middle Fork of the American River to its confluence with Duncan Creek (NE 1/4, NE 1/4, Sec. 29, T.14 N., R.13 E., MDM.). Then Northeasterly along Duncan Creek to the Duncan Diversion Dam.

THESE PROHIBITIONS ARE IN ADDITION TO THE GENERAL PROHIBITIONS CONTAINED IN 36 CFR PART 261.
